# PATROL DIVISION



The Patrol Division serves the residents of Broome County, being the primary law enforcement agency for 49.5% of the county's residents. Our Deputies serve the county's residents within the local municipalities as they attend school, work and shop outside the city and villages within the county. In an effort to further serve the residents of Broome County our Deputies provide service to the five municipal police agencies within the county and answers calls for service in those jurisdictions whenever a need arises. This Division is responsible for enforcing the laws of the State of New York while patrolling 1008 miles of state highways, 350 miles of county roads, and 927 miles of town roads on a twenty four hour, seven day a week basis. It is also responsible for patrolling the waterways throughout the county.

The Broome County Sheriff's Patrol Division is staffed as follows:

- 1 Captain
- 1 Lieutenant
- 6 Sergeants
- 26 Deputy Sheriffs

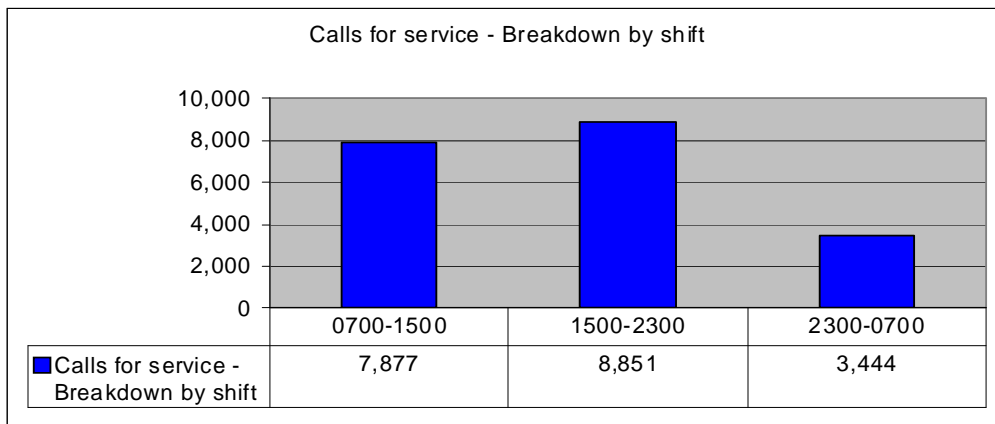
The Patrol Division handled 20,169 calls for service and an additional 11,921 deputy generated "quick calls" in 2010. Quick calls are generated by Broome Communications dispatchers when a deputy conducts a vehicle stop or exits his patrol vehicle to investigate a suspicious condition or check on a vehicle. A quick call may or may not be turned into an incident depending upon what the deputy finds. The following is a breakdown of the calls:

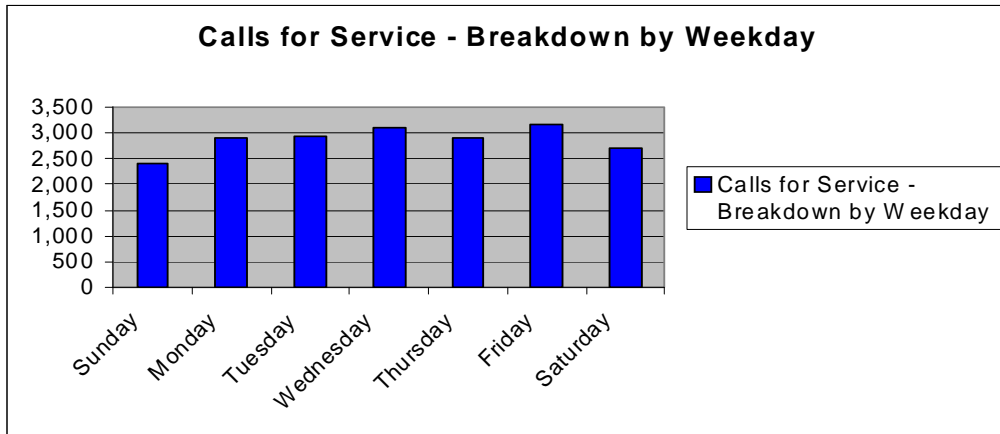


Deputies investigating an accident in the Town of Kirkwood

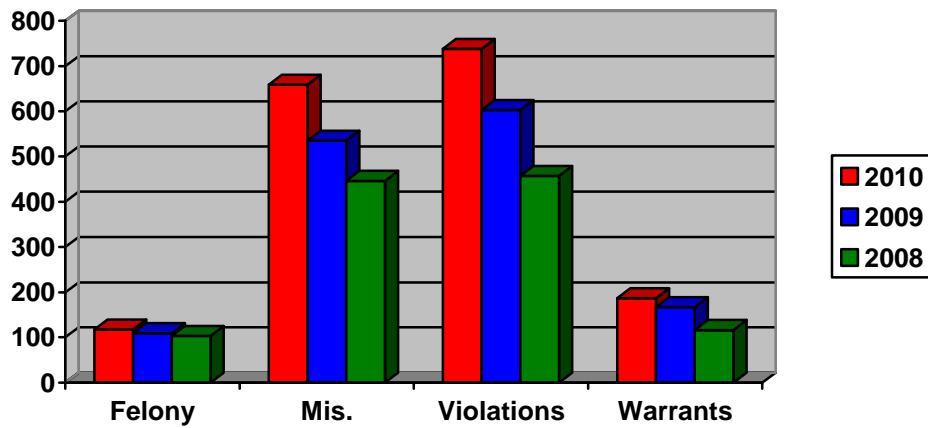

## Sheriff Motorcycle Unit Summary, 2010



The Broome County Sheriff's Motorcycle Unit is equipped with TWO Harley Davidson Police Motorcycles. One is a 2000 model FLHPI 88 Police Road King, designated as MC1. The second is a 2007 FLHPI 95 Police Road King designated as MC2. MC1 is equipped with a portable STALKER handheld radar unit that can be used for stationary speed enforcement. MC2 is equipped with a hard-mounted STALKER DUAL radar unit that can be utilized for both stationary and moving radar with both a front and rear antennae.

## MARINE PATROL

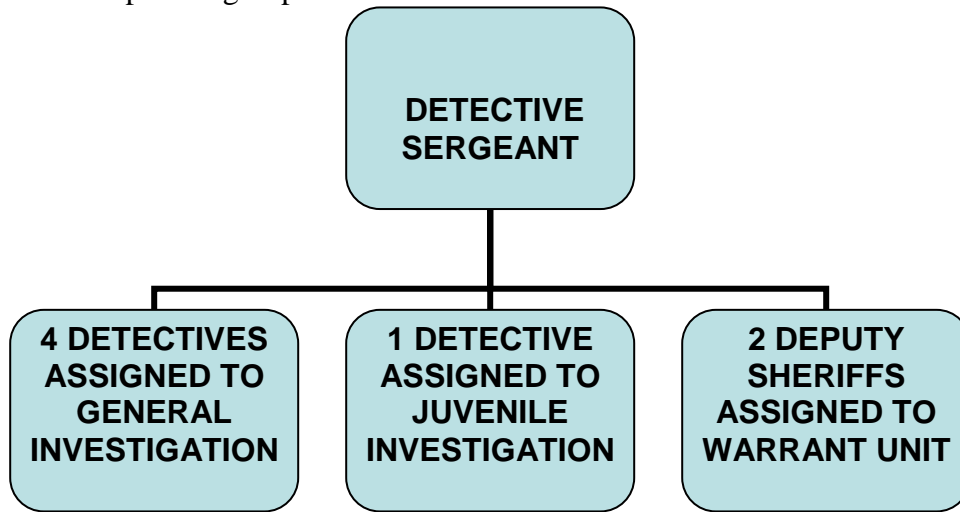


The Marine Patrol is comprised of two Patrol Sergeants and seven Deputies who are responsible for the enforcement of boating safety regulations, as well as conducting search, rescue, and recovery operations. These officers are also responsible for the verification and assignment of Hull Identification Number for registration purposes. This unit utilizes three boats to patrol the waterways of Broome County, a 14 foot Grumman aluminum boat powered by a 30 horse power Mercury motor, a 14 foot Quicksilver inflatable boat powered by a 25 horse power Mercury motor, and a 16 foot Rivercraft air boat. The Marine Patrol is also equipped with an underwater video camera and a Global Positioning System.



# DETECTIVE DIVISION

The Broome County Sheriff's Detective Division is comprised of two Detective Sergeants who supervise two units. The General Investigations Sergeant supervises four General Investigations Detectives, one Juvenile Detective and two Deputy Sheriff's assigned to the Warrant Division. The Special Investigations Sergeant supervises five SIU Detectives who are also assigned to the Broome County Special Investigations Task Force. Members assigned to the Division maintain the sex offender registry, DNA gathering registry and evidence control. Members are assigned to the Southern Tier Child Predator Task Force, Operation Impact, Child Advocacy Case Review Committee, Gang Task Force Meetings, Counter Terrorism Zone Meetings, Bank Security Meetings and Retail Security Meetings. Members also provide presentations to various government and private groups.



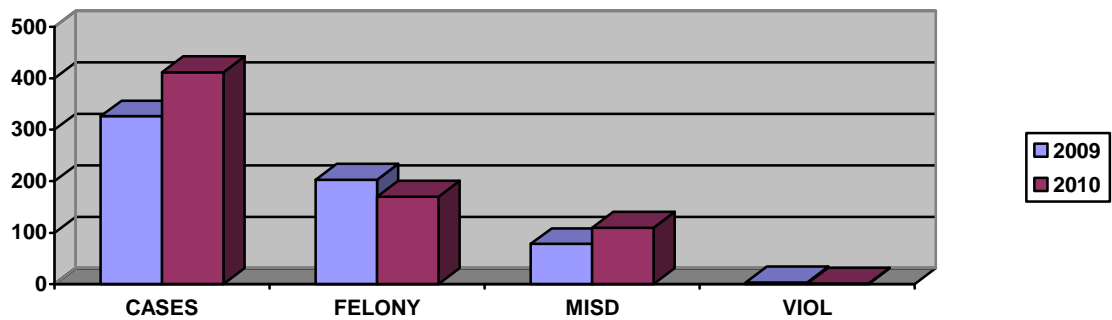

The Detective Division is responsible for monitoring sex offenders in Broome County. We work in partnership with area law enforcement agencies and provide a notification service through *OffenderWatch*®.

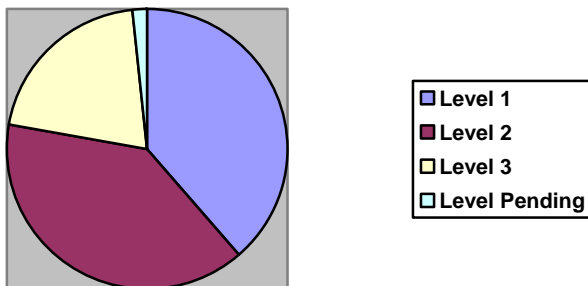

Broome County's law enforcement utilizes *OffenderWatch*® to manage and monitor the whereabouts, conduct and compliance status of the registered offenders in Broome County. *OffenderWatch*® provides the most accurate and timely information available and now this information is available to you!

*OffenderWatch*® is updated instantaneously throughout the day as offender addresses and other offender information is updated in our office. You may enter any address in the County and see real-time information on the publishable offenders within the specified radius of the address you enter.

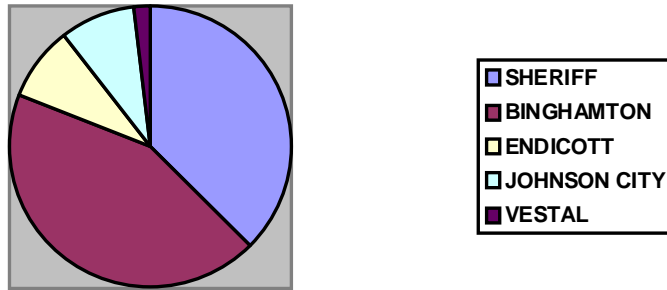
Offenders move frequently, so instead of having to check the maps on a weekly basis, the best way to stay informed is to take advantage of our free email alert system. You may confidentially register as many addresses in the County as you wish, and we will continuously monitor the addresses and send you an email alert if a new offender registers an address within the specified radius of any address you register. There is no cost for this service and no limit to the number of addresses you can register - your email address and physical addresses are all confidential. Tell your friends and neighbors and be sure to register your home, school, work, gym, day care, park, soccer field, parents or children's homes - any address of interest to you!

There were a total of 17,213 sex offender post cards mailed out for the 177 person who are registered sex offenders.

### WARRANT UNIT

The Warrant Control Unit of the Broome County Sheriff's Office is comprised of two, (2) Deputy Sheriffs under the direction of the Detectives Sergeant assigned to General Investigations. The unit is responsible for the management of warrants issued to the Broome County Sheriff's Office by Broome County Supreme Court, Broome County Family Court and local Justice Courts throughout Broome County. The deputies assigned to the unit insure entry of each warrant received into the Broome County Public Safety System and NYSPIN (New York State Police Information System) to readily identify wanted persons who may be encountered by Police Officers locally or nationwide.

The Broome County Sheriff's Office continues to work with New York/New Jersey Regional Fugitive Task Force. Four Sheriff's Office members are sworn United States Deputy Marshals. They work along with members of the Marshal's Service, Binghamton Police Department and New York State Police. The task force increases the resources available to better track fugitives not only in New York State but across the country.

The Warrant Control Unit distributes the warrants issued by Local Criminal Courts to Highway Patrol Deputies for execution and monitors the action taken. The Unit is responsible for the execution of all Broome County Court and Broome County Family Court warrants. In addition to New York State, the Unit is responsible for the extradition of wanted subjects that are located outside New York State.



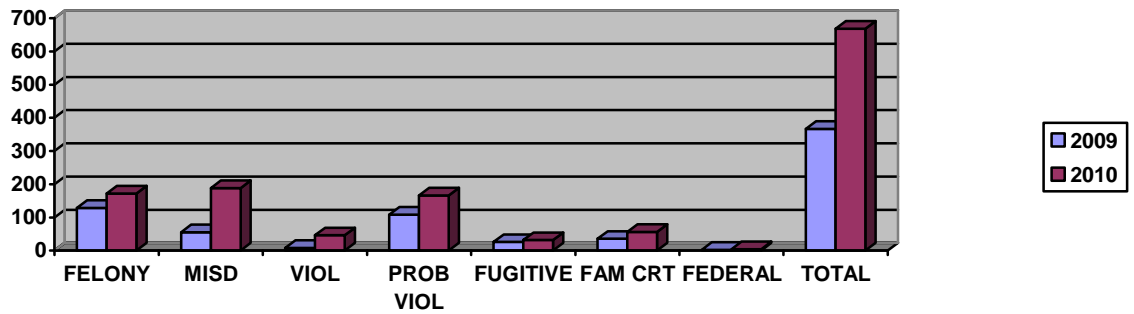

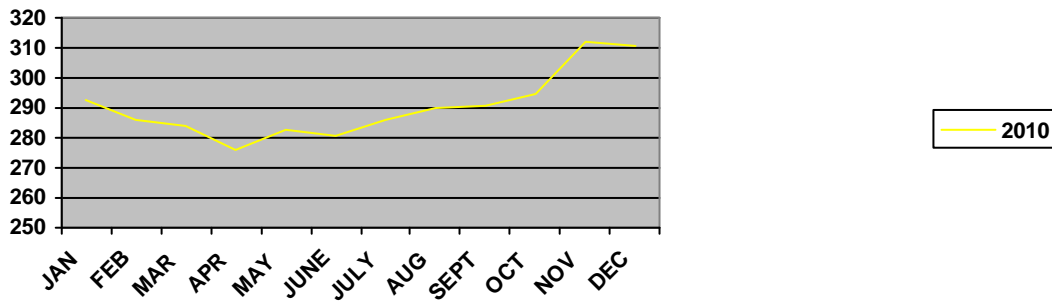

### WARRANT ARREST COMPARISON 2009-2010

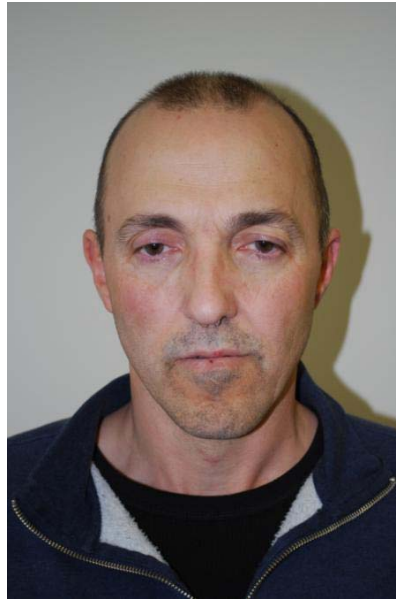


### ACTIVE WARRANTS BY MONTH

### **FUGITIVE CASES**



**ANTHONY PAVONE**



**TRUCK AT THE DELL MOTEL COURT STREET  
KIRKWOOD NEW YORK**

Anthony Victor Pavone of Morrisonville, New York is alleged to have gone to the residence located in the Town of Dannemora, New York in the early morning hours of January 31, 2010 and murdered his estranged girlfriend and her boyfriend. On February 5, 2010 Anthony Pavone and Pavone's 2001 Sierra GMC truck were located at the Del Motel in the Town of Kirkwood by Broome County Sheriff's Deputy Thomas Sienko. Upon locating the vehicle, contact was made with Pavone inside room 20 of the motel by Broome County Sheriff's negotiators. Following several hours of negotiations, negotiators were able to have Pavone exit the hotel room at approximately 4:00 a.m., at which time Pavone was arrested on two counts of Murder Second Degree.



**RICHELLE L VASQUEZ**

On December 8, 2010 Richelle L Vasquez 31yoa of Johnson City was charged as a fugitive from justice from Bexar County Texas. Vasquez fled Texas after being involved in a Murder that took place in May of 2010. Bexar County Sheriffs Office Detectives tracked Vazquez to the Broome County area and worked with Broome County Sheriffs Detectives to locate and interview Vasquez. Vasquez was taken into custody and following a court appearance extradited to Texas to stand trial.

**SUBJECT ARRESTED FOR TRAVELING TO  
HAVE SEX WITH UNDERAGE FEMALE**



**Viktor Zhadanov**

On January 9, 2010 Viktor Zhadanov 26yoa of Belleville New Jersey was charged with 2 counts of Criminal Sexual Act 1<sup>st</sup> degree class B Felonies. Zhadanov is accused of traveling from New Jersey to New York in May of 2009 and forcing a female under 16yoa to engage in oral sex. Zhadanov had contacted the female through an internet chat room then made arrangements to travel to New York.

Zhadanov was arrested by Detectives when he traveled back to the Broome County area to again meet with the underage female. At the time of his arrest Zhadanov was on bail

from a case in the State of New Jersey where he was accused of sexually assaulting a 13yo female.

Christopher L Knapp 27yoa, Jeremy F Knapp 23yoa and Timothy E Daum 22yoa all of Windsor were charged in relation to a home invasion robbery that took place on June 1, 2010 around 3:30am today in the Village of Windsor. The subjects are accused of entering a residence and assaulting two occupants of the residence while stealing money from the occupants. The subjects fled with an undisclosed amount of money. While fleeing the scene of the home invasion the subjects were involved in an accident then fled on foot from the accident scene. They were located a short time later at a residence on Shedd Road in the Town of Windsor. The three were charged with Burglary in the 1<sup>st</sup> degree, Assault in the 1<sup>st</sup> degree and Conspiracy in the 4<sup>th</sup> degree all felony level crimes.

## **FORCIBLE RAPE SOLVED WITH DNA**

In August of 2010 Nicholas W Weidow 19yoa of Binghamton was charged with Rape in the first degree a class B Felony. Weidow is accused of raping a female at a party in a wooded area off Carlin Road in Conklin in April 2010. Weidow was developed as a suspect and detectives were able to secure DNA evidence from the crime scene. After comparing DNA from Weidow to the DNA at the crime scene it was determined Weidow was an exact match and he was charged.

### **Counterfeit \$100 bills found in suspect vehicle**

On October 14, 2010 the Broome County Sheriff's Office responded to a 911 call of a subject attempting to pass a counterfeit \$100 bill. Deputy Scott Morgan responded to the call at the Speidi and Rib Pit at 1268 Upper Front Street in the Town of Chenango. Upon arrival Deputy Morgan was able to obtain a suspect description.

Two other calls were received of persons attempting to pass counterfeit \$100 bills by the Broome County Communications Center one from Friendly's Restaurant at 1148 Upper Front Street and one from Weiss Market 1290 Upper Front Street. The caller from Weiss Market was able to provide the dispatcher with a vehicle description and license plate number for the suspects. The information was immediately broadcast by dispatchers to responding officers.

Within minutes New York State Trooper Timothy Conklin observed a vehicle matching the description on Interstate 81 south in the area of exit 3. Trooper Conklin initiated a traffic stop on the vehicle and detained four males from the New York City area.

Sheriff's Detectives and Secret Service Agents from Syracuse conducted interviews of the subjects and canvassed businesses in the Upper Front Street area through-out the evening. It was determined that counterfeit \$100 bills were passed or attempted to be passed at 10 businesses along Upper Front Street. As a result the following were subjects have been charged.

Marqus Dehawn Garrett 21 years of age of New York, New York was charged with five counts of Criminal Possession of a Forged Instrument a class C felony and one count of Conspiracy in the fourth degree a class E felony.

Dion C Atkinson 22 years of age of Queens, New York was charged with one count of Criminal Possession of a Forged Instrument a class C felony and one count of Conspiracy in the fourth degree a class E felony.

Also recovered in the investigation were 14 counterfeit \$100 bills and one fake \$20 bill. Detectives also seized \$5445.00 in genuine currency.

## **SEX OFFENDERS ARRESTED FOR REGISTRY VIOLATIONS**



**Robert L Miller**

On January 29, 2010 Robert L Miller 50yoa of Windsor was charged with Failure to Register Change of Address Under the Sex Offender Registration Act, a class E Felony. Miller failed register a change of address with the Sheriff's Office within the required 10 day time period. Miller a level 2 sex offender was convicted of Sexual Abuse in the 2<sup>nd</sup> degree in 2003.



**Billie Ray Burnside**

April 12, 2010 Billie Ray Burnside 26yoa was charged in connection with a violation of the Sexual Offender Registration Act. Burnside a level 3 sex offender transferred to New York State from Oklahoma where he was convicted of a sexual offense against a 14yo female. He had filed an address change with the New York State Department of Criminal Justice Services. Burnside who originally resided in Cortland County after moving to New York indicated he moved to the Whitney Point area on March 30, 2010. During an investigation it was determined Burnside was in fact not living in Whitney Point but at various unreported addresses.

# **BROOME COUNTY SPECIAL INVESTIGATIONS UNIT TASK FORCE**

The Broome County Special Investigations Unit Task Force is made up of members of the Broome County Sheriff's Office the City of Binghamton Police Department and the Village of Johnson City Police Department. Currently the Broome County Sheriff's Office has a Detective Sergeant and five Detectives assigned to the Task Force; the City of Binghamton Police Department has a Sergeant and five Investigators assigned to the Task Force. During the year 2010 the Task Force saw the loss of a Lieutenant who was assigned by the City of Binghamton, however during the same time frame the Village of Johnson City Police Department committed one investigator to the Task Force, which allowed the total number of personnel assigned to the Task Force to remain at 13.

It is the mission of the Broome County Special Investigations Unit Task Force to work together as one cohesive unit to combat the illegal possession and distribution of narcotics, investigate and see to the successful prosecution of the criminals who partake in these activities and also to disrupt prostitution activities in and around the Broome County area.

At the beginning of 2010 members of the Task Force had established four goals that they wished to achieve during the year. One of the goals was to revisit its forfeiture protocols and procedures and attempt to streamline the process to make it more efficient. The Task Force along with the District Attorney's Office has established a standard forfeiture reporting system which allows members of the Task Force to submit a standardized form to the prosecuting attorney regarding their wish to seize assets as part of their investigation. This newly implemented process will hopefully allow more currency and vehicles to be seized; these seized assets are then placed into official use, which will take a small burden off of the taxpayer.

A second goal that the Task Force wished to achieve was to bolster its efforts in enforcing the Alcohol Beverage Laws of the State of New York in an effort to combat underage drinking. In 2010 members of the Task Force worked closely with the State Liquor Authority and the New York State Department of Motor Vehicles and specifically targeted "Frat Houses" within the City of Binghamton. By doing this, several arrests were made for underage drinking and several "fake ID's" were confiscated.

The third goal and one of the most important was for the Task Force to strengthen its relationship with outside agencies in an effort to efficiently and effectively succeed in its mission. A perfect example of how the Task Force has achieved this goal was by the Village of Johnson City Police Department assigning an investigator to work directly with members of the Task Force. The addition of the investigator allows all members to streamline all investigations that are being conducted within the Village of Johnson City. It also allows the investigator from the Village to share a wealth of information that he/she has obtained regarding activities that are happening within their respective jurisdictions.

The fourth and final goal the Task Force wished to achieve was a stronger focus on illegal gang activity. That focus would require the Task Force to shift their focus from



conventional investigations to long term investigations utilizing a multi-agency approach. In 2010 members of the Task Force along with the New York State Police Special Investigations Unit-Binghamton and the Federal Bureau of Investigations conducted a three month long investigation dubbed: "Operation Third Strike". The purpose of the investigation was to identify violent street gang members and target them for the illegal possession and distribution of cocaine in the Broome County area, primarily in the City of Binghamton. (See notable cases, for details surrounding this investigation.)

Working towards achieving the fourth goal members of the Task Force partnered up with the New York State Police Special Investigations Unit-Binghamton and conducted another long term investigation regarding the illegal possession and distribution of cocaine and the illegal sale of firearms. This investigation netted several arrests for possession and sale of narcotics as well as the illegal possession of firearms. (See notable cases, for details surrounding this investigation.)

### **Objectives for 2011**

- Continue to bolster our relationship with agencies outside of the Task Force in an effort to most effectively and efficiently achieve each agency's goals as they pertain to their specific mission.
- Upgrade the undercover monitoring devices that are utilized by members working in an undercover capacity. Therefore establishing protocol to achieve the highest level of evidentiary value to the captured conversations and actions of those committing the targeted crimes.
- While conducting investigations as they pertain to Special Investigations, attempt to specifically target those who are associated with street gangs as well as those who have violent criminal records.

## NOTABLE INVESTIGATIONS

### **Person Arrested After Search of Residence Yields Handgun, Heroin and U.S. Currency:**

In January 2010, members of the Task Force executed a Search Warrant at a residence located in the Village of Johnson City. A search of the residence yielded a defaced .25 caliber handgun, 18 bundles of heroin packaged for sale, and U.S. Currency. A resident of the searched location was arrested and charged with felony Criminal Possession of a Weapon and Criminal Possession of a Controlled Substance. The recovered handgun had a defaced serial number.



## **Two People Are Arrested After Search of Residence Yields Two Handguns and Crack Cocaine:**

In February 2010, members of the Task Force executed a Search Warrant at a Village of Johnson City residence. A search of the residence yielded a .45 caliber and a .38 caliber handgun along with crack cocaine. Two people were taken into custody and both were charged with Criminal Possession of a Weapon and Criminal Possession of a Controlled Substance.



## **Two People Arrested After Task Force Members Discover They Were Operating a One Stop Street Drug Store From Their Residence:**

In March 2010, members of the Task Force executed a Search Warrant at a City of Binghamton residence. A search of the residence yielded a loaded .22 caliber handgun, crack cocaine, powder cocaine, heroin, ecstasy, and marihuana. The couple that owned the residence were both arrested and charged with a weapon charge and several counts of narcotic charges.





### **Two Individuals Arrested After Search of Residence Yields Marihuana and U.S. Currency:**

In April 2010, members of the Task Force arrested two individuals after an execution of a Search Warrant at a residence located in the City of Binghamton. During the search of the residence, Investigator's discovered a hidden compartment behind a bathroom shower. Secreted in the compartment was approximately 16 pounds of marihuana and over \$10,000.00 in U.S. Currency. Two people were charged with Criminal Possession of Marihuana in the First Degree.



## Blood Gang Members Arrested in Long Term Investigation dubbed “Operation 3<sup>rd</sup> Strike”:

For several months members of the Task Force, along with several other law enforcement agencies, conducted an investigation that focused on criminal activity of the Bloods street gang. The operation was titled “Operation 3<sup>rd</sup> Strike”. In order to further the investigation, members used surveillance, wiretaps, undercover operations, and Search Warrants to build cases against several gang members. As a result of the investigation, a total of 15 gang members were arrested. The charges stemmed from Federal Narcotic Conspiracy charges to gang assault charges and weapon charges. During the course of the investigation, three handguns and approximately 250 grams of cocaine were recovered. In addition, members of the BCTF are still working with members of the Binghamton Police Detective Division in furthering investigations into other violent crimes that are believed to be gang related.

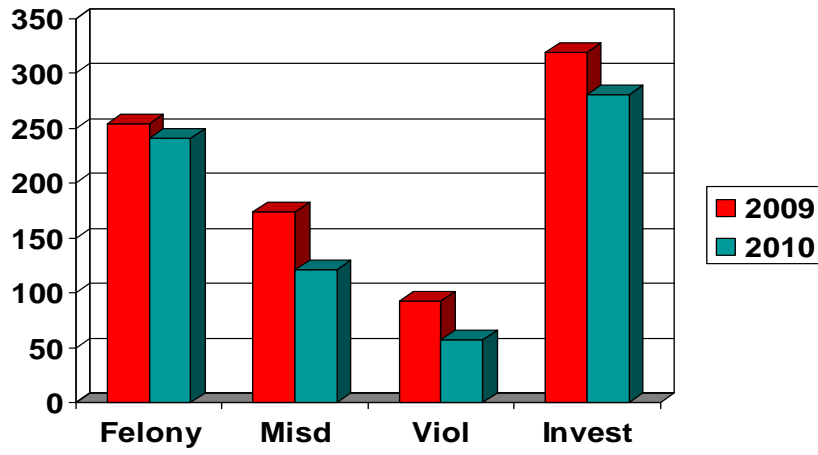

## Narcotics & Weapons Distribution Ring Taken Down in Broome County:

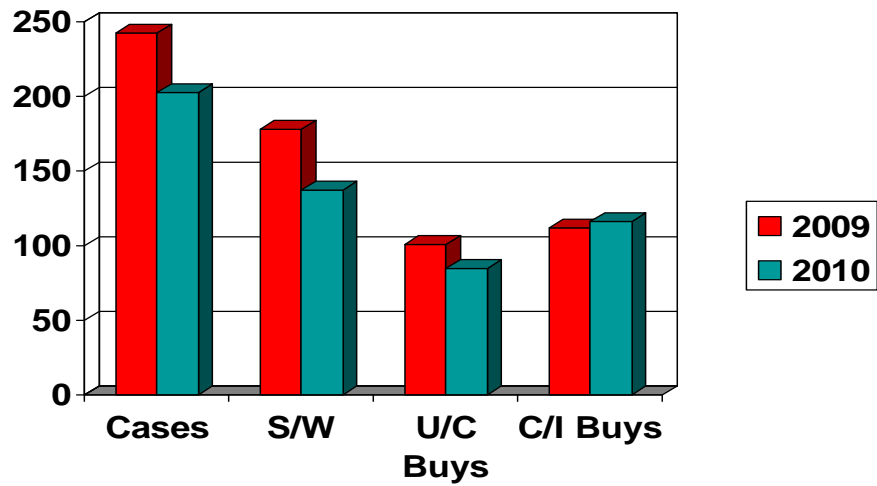
In 2010, members of the Task Force along with NYSP started an investigation into a cocaine distribution and weapon sales ring that was operating in the City of Binghamton and Broome County. After using various investigative techniques to further the investigation, four individuals were arrested on crimes ranging from narcotic possession to illegal weapon possession. This investigation resulted in shutting down a narcotics/weapons distribution ring where suspects were transporting cocaine and handguns from the New York City area and then selling them to persons in Broome County. As a result, handguns and approximately 250 grams of cocaine were recovered that otherwise would have ended up on the streets in Broome County.

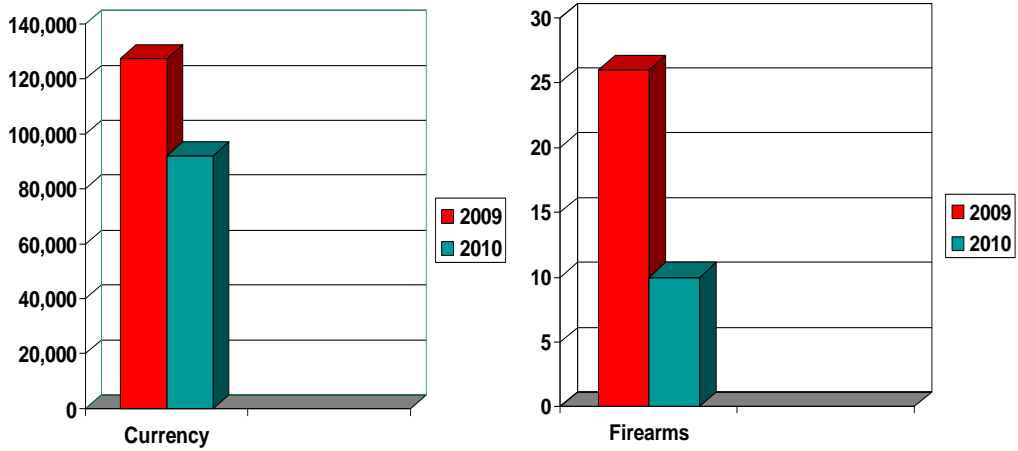

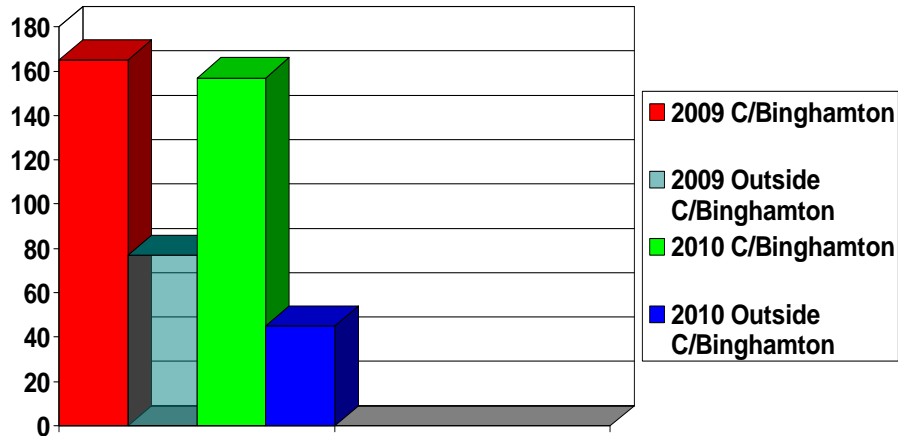




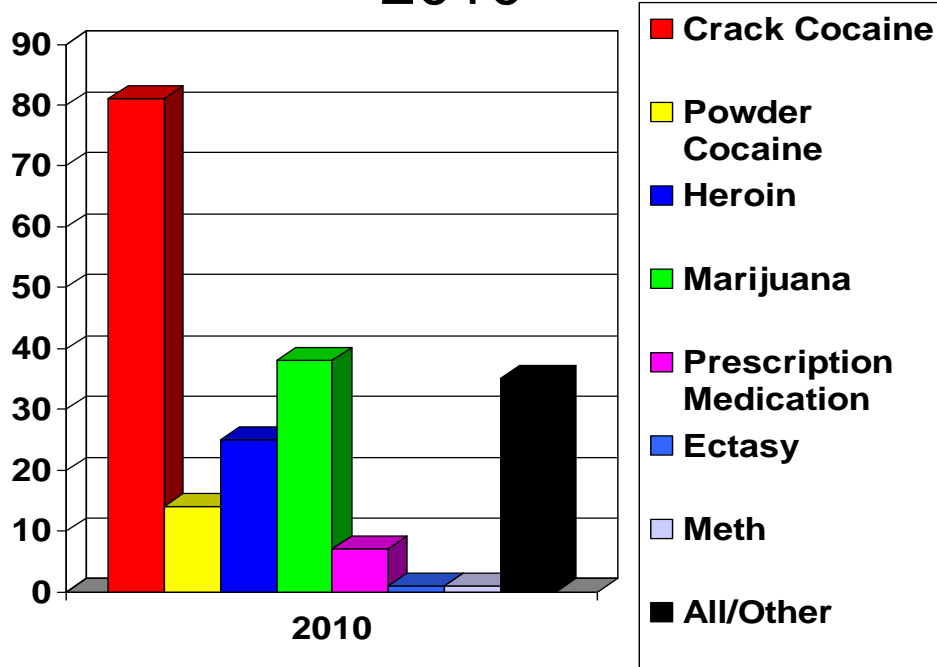

# 2009/2010 Statistical Comparison Cont. Location of Investigations



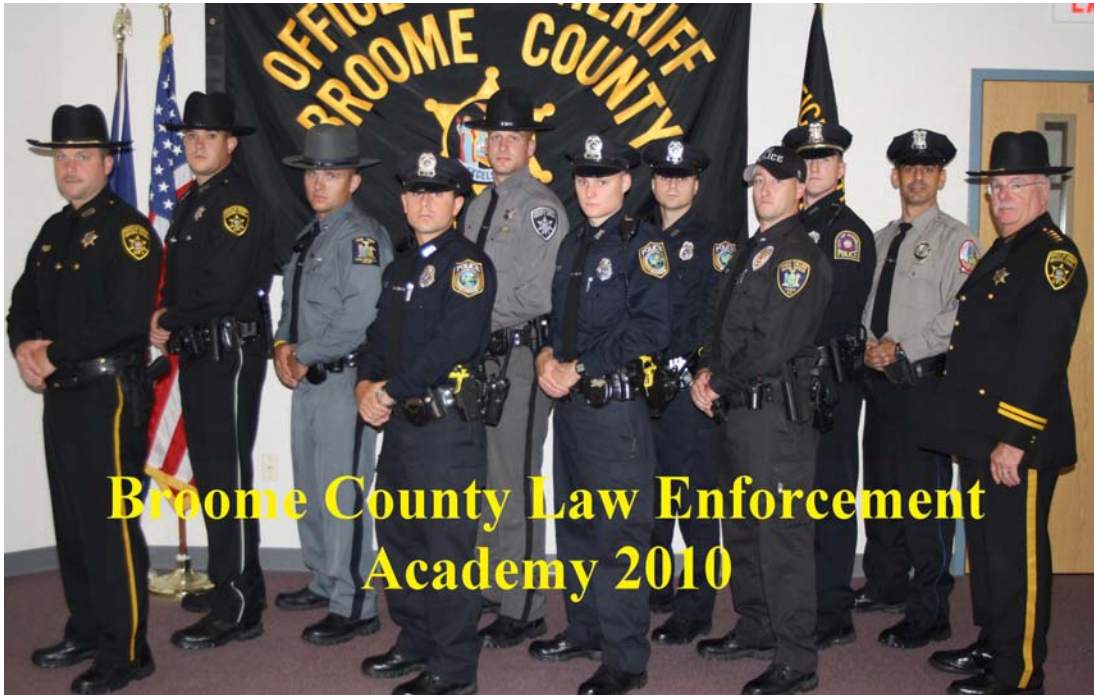
# Investigation by Drug Type 2010



# Law Enforcement Training Division

The Law Enforcement Training Division is also the home of the New York State Zone 6 Law Enforcement Academy. The Zone 6 Academy provides training for 40 police agencies in 7 counties. Agencies of and in those 7 counties, Broome, Chenango, Cortland, Delaware, Tioga, Tompkins and Otsego depend on the Academy to provide a wide range of in-service training for veteran officers as well as the Basic Course for Police Officers to train new recruits.

# Community Policing/School Resource Officer

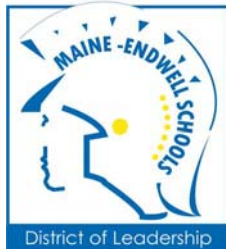
The Community Policing Divisions employs one full – time Deputy. This Deputy is responsible for all Community Service Projects as well as serving as a full time School Resource Officer.

The School Resource Officer program is a collaborative effort by certified law enforcement officers, educators, students, parents and the community to offer educational programs in the schools to reduce crime, drug abuse, and violence and provide a safe environment. It is the responsibility of the Deputy to focus on the needs of the school and assist the administration in accomplishing their goals.

The School Resource Officer is committed to promoting a concept of school based law enforcement. This TRIAD concept allows the School Resource Officer to act as a Teacher, Counselor and Law Enforcement Officer. School Resource Officers work with students, parents and school staff on a daily basis. The Deputy is required to develop and teach lessons to students on numerous subjects.

Officers also assist students, parents and staff as counselors. Counseling sessions may be for behavioral problems or for persons in crisis. The Deputy talks to students regarding careers in Law Enforcement. The Deputy also assists the school in their disaster planning issues. They conduct investigations of incidents in and around the school. They also make any arrests, as a result of these investigations.

The Broome County’s School Resource Officer works in the Maine Endwell School District, as well as the Chenango Valley School District. This partnership of law enforcement, school district, parents and the community, provides a safe and successful learning environment.



## School Resource Officer Advancement

For 2010, the SRO has been assigned a newer patrol car. This car is a “slick top” car, meaning it has no light bar on the roof. This was set up for the SRO to blend in with traffic and other vehicles more, to catch motorists passing school buses and speeding in school zones. This patrol car has all the normal capabilities as a regular patrol car such as a computer, printer, radar, and other traditional police equipment. This position has been changed slightly to become more proactive, in sense of responding to more priority calls near or around the school that the Deputy is in.

**Neighborhood Watch Programs**

The Broome County Sheriff’s Office continues to work with the citizens within the County, helping them establish Neighborhood Watch groups. This program encourages citizens to be active within their neighborhood in preventing crime and assisting the police by being good observers in the community. The Broome County Sheriff’s Office added one new Neighborhood Watch community to bring the total up to 22 groups. The new Neighborhood Watch was added is in the Town of Union (Tracy Street, Riverview Drive, Louisiana Avenue area).

**Safe Senior Programs**

The community policing division educated over 75 seniors this year on the issues of telemarketing fraud, investment scams, auto safety and theft prevention. Programs were offered at local senior centers and housing and area churches.

## Grants

The Community Policing Office authored 3 grants for the 2010 year. These grants totaled \$51,628.00.

Selective Traffic Enforcement Program (STEP). This \$22,128.00 grant paid for additional 200 patrol hours on Broome County Highways. Deputies used these hours to curb aggressive driving habits, thus lowering motor vehicle accidents attributed to aggressive driving. Along with the additional hours, we were able to purchase \$12,128 worth of traffic enforcement equipment for patrol vehicle. This included advanced and up to date radar systems, and two new laser guns for stealth mode enforcement.



Buckle Up New York (BUNY) Campaign. This grant was for a total of \$10,000.00, and was used to place 200 additional Deputy Patrol hours on Broome County Highways to curb the nonuse and misuse of seat belts.

Child Safety Seat Grant. The grant of \$19,500.00 allowed the Sheriff to purchase new child safety seats and distribute them to needy families in Broome County. This grant also paid for four deputies to become Child Safety Seat Technicians. This brought the number for Deputies who are technicians up to 10 Deputies. These Deputies can not only enforce the safety seat law, but take the extra time to educate parents and children about their safety seats.



### Speed Trailers

The Broome County Sheriff's Office continues to utilize two Speed Trailers. The Speed Trailers are self-contained units that are equipped with their own power source and speed-measuring equipment. When they are set up in a specific area, they display vehicle speeds.

The trailers are pre-programmed to light up the speed of the vehicle and if the vehicle exceeds a pre-determined speed, the unit will flash the speed and inform the driver of their violation. These Tracker Trailers have proven to be very effective in curbing speeding vehicle problems. The trailers have been moved more than often in 2010, with increased number of speed related complaints. Once the trailers are set up, it is announced in roll call for Deputies to not only check on the trailers, but to provide extra patrol in the areas of request. The speed trailers were deployed in more than 30 different locations in 2010.

# Law Enforcement Explorer Program

The Sheriff's Office hosted a new group of Law Enforcement Explorers in 2010 with a total of 21 Explorers. Explorers learned the basic fundamentals of law enforcement through various classes. Several guest speakers came to teach about different law enforcement occupations including an Agent from the F.B.I., and a K-9 Deputy. Explorers helped with community service by traveling with a Deputy to the New York State Sheriff's Camp, and assisted them with an 8 hour day of labor intensive work helping the camp open for the summer.

Explorers made a vote to change the Explorer patch for the post. Many ideas were brought to the table, but only one won the honor of being our new patch.

Post 2100 was held from September through late June, 2010.





# CORRECTION DIVISION

The Broome County Sheriff's Correctional Facility is committed to the protection of the citizens of Broome County, assuring operational security of the facility, while providing safe, humane treatment of all persons housed within the facility, and providing opportunities for participation in programs which assist in developing skills for reentry as a citizen of this community. The Correctional Facility continues to operate within the guidelines established by the New York State Commission of Correction.

The facility administration has made gang intelligence, information sharing, entrance security and contraband interdiction a top priority during 2010. There has been an increase in the number of arrests for crimes committed within the facility. Recently an inmate was discovered with a lighter in his possession. The Corrections Investigation Unit worked closely with the Broome County District Attorney's Office, and successfully argued in court that a lighter inside a correctional facility is dangerous contraband. This inmate was convicted by a trial jury for Promoting Prison Contraband in the first degree which is a Class D Felony. The inmate received a 3-7 year state prison term.

Several capital projects were completed in year 2010. The showers in E & G pods were completely resurfaced. This process involved removing the current surface and replacing it with fresh paint and applying a more durable sealant, with a lifetime warranty on the new surface. New carpeting was installed in C-Pod. New tables were purchased for the C-Pod common area as well as for all of the program rooms in every housing unit, insuring a safer living environment.

Throughout the course of the year, the administration worked to implement and revise the best course of action that would provide the most effective use of our critically-limited resources to get the "Best Bang for the Buck." Through innovative thinking and strategies our efforts have paid-off. Overtime was drastically reduced. The dollar amount spent on overtime was reduced significantly and was under budget in the year 2010. This was a great accomplishment showing the commitment the supervisory personnel made towards running a leaner cost effective operation.

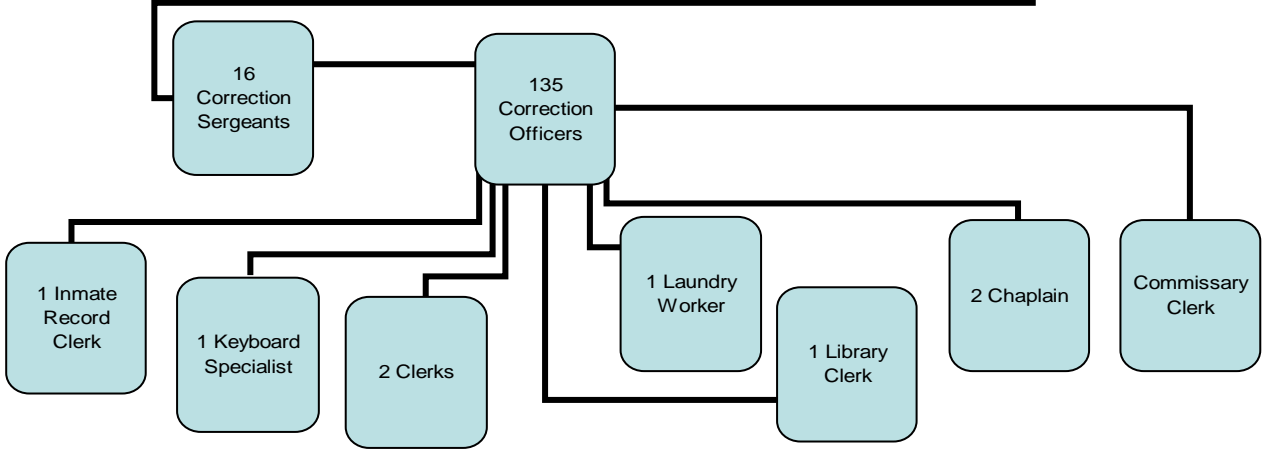

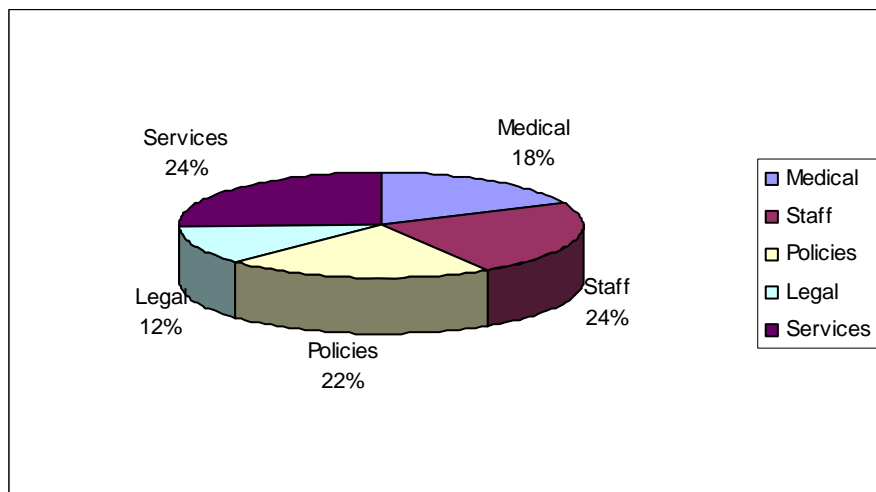
## **INMATE GRIEVANCE PROGRAM**

New York States Minimum Standards for correctional facilities states: “In order to provide an effective and impartial procedure for the timely resolution of inmate complaints, the chief administrative officer of each local correctional facility shall establish, implement and maintain a formal inmate grievance program. Every effort shall be made to resolve inmate complaints in an informal manner.” The Correction Division has one full time officer completely dedicated to processing and resolving inmate grievances

The term “grievance” is defined as a written inmate complaint concerning either written or unwritten facility policies, procedures, rules, practices, programs or the action or inaction of any person within the facility. Dispositions, surcharges, and sanctions resulting from disciplinary hearings and administrative segregation housing decisions cannot be the subject of a grievance. The chief administrative officer or his designee ensures that each grievance is investigated to the extent necessary by an impartial person. Failure to supply sufficient information or evidence within two days shall be cause to deny the grievance. Grievances regarding dispositions or sanctions from disciplinary hearings, administrative segregation housing decisions, issues that are outside the authority of the chief administrative officer to control, or complaints pertaining to an inmate other than the inmate actually filing the grievance are not grievable and may be returned to the inmate by the grievance coordinator. Such grievances may not be appealed to the chief administrative officer or the Citizens’ Policy and Complaint Review Council (Appeal to the Commission of Correction). A copy shall also be given to the members of the Council for their review. If such determination is in favor of the grievant as a matter of law, the chairperson of the Citizens’ Policy and Complaint Review Council shall direct the chief administrative officer to comply with the grievance and provide an appropriate remedy.

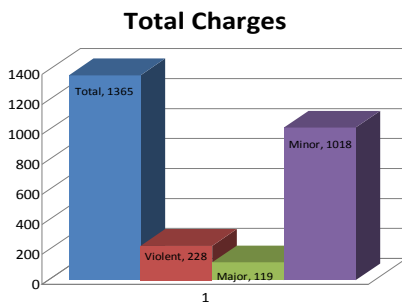

## INMATE DISCIPLINARY PROCESS

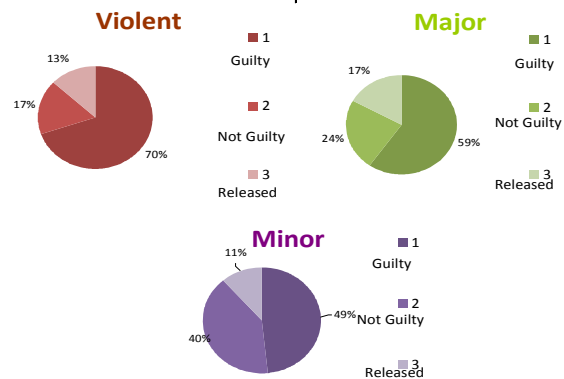
The position of hearing officer is vital to the safe and secure operation of the facility. The staff that makes up the team ranges from the Line Officer, the Programs Sgt., Security Lieutenants, and the Jail Administrator. 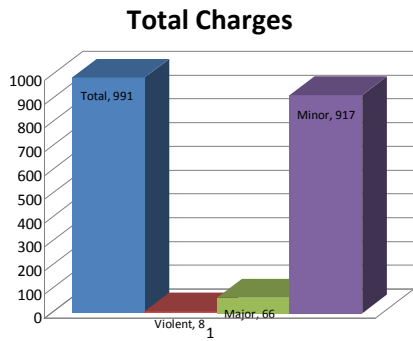

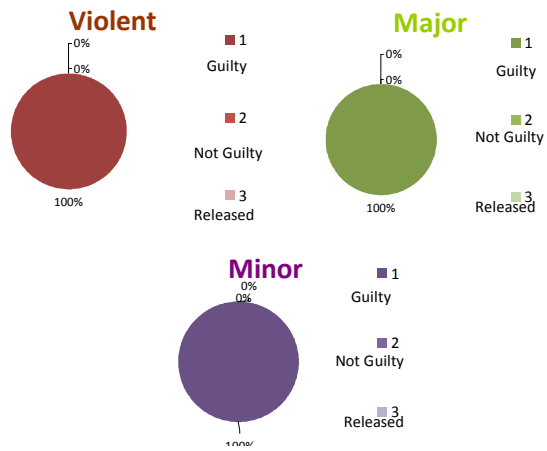

## Medical Services

The Health Services Unit of the Correctional Facility has a comprehensive unit medical approach that combined both the medical services and forensic mental health service under one provider. The combined contract was awarded to Correctional Medical Care. The facility and county has benefited by a continuity of care not seen in the past. The unit is working very well in meeting the demanding needs of a growing population, while continuing to control costs.

The transition to a cohesive medical unit was smooth with most of the former medical service employees retaining employment. The unit has worked hard in maintaining the high level of service demanded by the Sheriff's Office. The current **National Commission Correctional Health Care** accreditation was reviewed and **both Medical and Mental Health did receive full accreditation in 2010**. But what, exactly, is accreditation? Established in the 1970s, it's a process of external peer review in which NCCHC, a private, not-for-profit organization, grants public recognition to correctional institutions that meet its nationally accepted *Standards for Health Services*. Through the accreditation process, NCCHC renders a professional judgment regarding health services provided and assists correctional facilities in their continued improvement.

## Accreditation

Developed by experts from the professions of health, law and corrections, separate standards exist for health care delivery in jails, prisons, and juvenile detention and confinement facilities.

The areas covered by the *Standards* include:

- Facility governance and administration
- Maintaining a safe and healthy environment
- Personnel and training
- Health care services support
- Inmate care and treatment
- Health promotion and disease prevention
- Special inmate needs and services
- Health records
- Medical-legal issues



Health services accreditation confers many benefits. It promotes and documents an efficient, well-managed system of health care delivery. It lends prestige to the facility, increases staff morale, aids recruiting efforts, helps to obtain community support and provides additional justification for budgetary requests. Accreditation can help protect financial assets by minimizing the occurrence of adverse events. In many instances, accreditation reduces liability premiums and protects facilities from lawsuits related to health care.

## **Criminal Investigations Unit** **Corrections Division**

The Criminal Investigations Unit of the Corrections Division is a sub unit of the Corrections Division, made up of select officers trained as investigators. These officers receive two weeks of criminal investigations training as well as periodic specialized training in areas that are relevant to their duties.

Currently, there are twelve officers assigned to the unit plus one Sergeant assigned as Direct Supervisor and one Lieutenant as Direct Command oversight for the unit, with the Captain and Major of the division completing the command structure.

CIU is tasked with the responsibility of investigating any criminal activity that occurs within the Sheriff's Correctional Facility and the arrest and prosecution of the perpetrators. The unit is also responsible for the collection, verification, and dissemination of gang intelligence as well as maintaining the Sheriff's Gang Database. This database is a resource for county wide law enforcement on gang activity and gang intelligence.

The Supervisor of the unit is tasked with conducting background investigations on all potential new officer hires and civilian employees for the Corrections Division. Further, the Supervisor is responsible for all divisional internal investigations, acting as Internal Affairs for the Corrections Division, the Captain and Major of the division are in direct command of these responsibilities conducted by the Supervisor.

The unit also functions as an arm of Criminal Intelligence, assisting local Detective Divisions and other police agencies with relevant information for ongoing investigations or identification purposes. The Intelligence Officer who works in conjunction with a Detective for the Binghamton Police Department conducted 262 agency assists by monitoring the inmate activity.

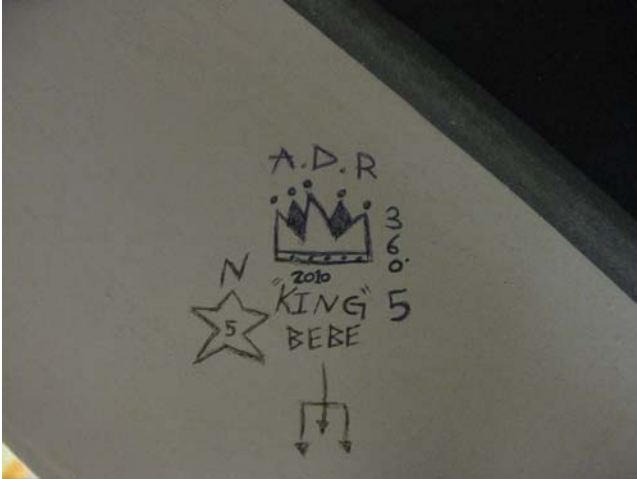

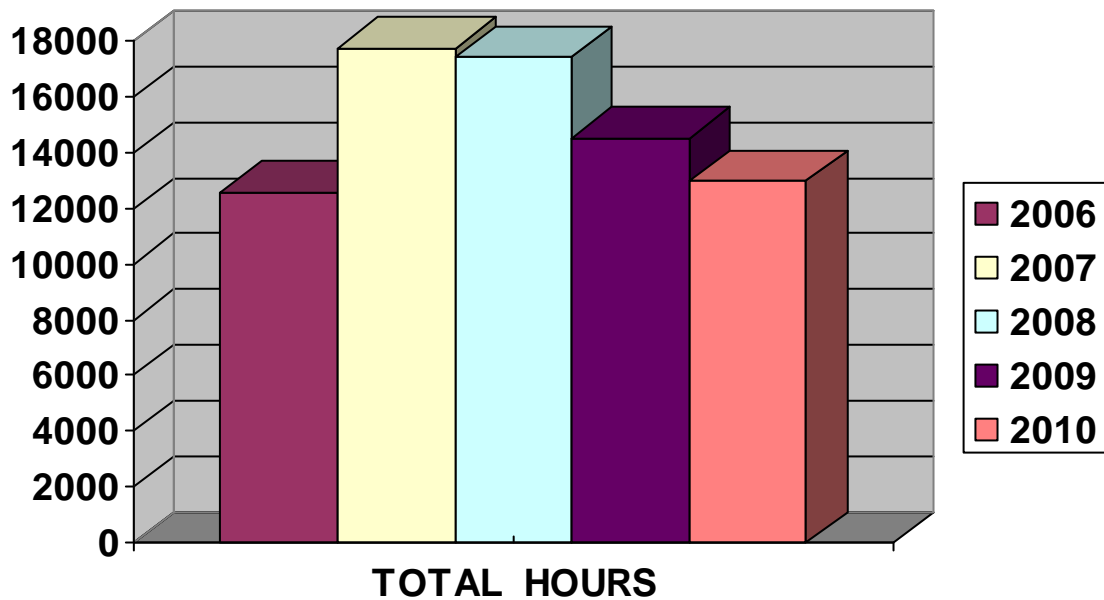

## **Corrections Training Unit 2010**

The Corrections Training Unit of the Broome County Sheriff's Office is staffed by Sergeant Steven Petryszyn. Since the Corrections Profession is continuing to change, the Corrections Training Unit has sustained its endeavor to meet these changes. The 160 hour Basic Course for Correction Officers graduated 13 Officers from 5 different counties. The training for the Emergency Response Team continued to be directed at the always present threat of physical violence within the correctional facility. Officers from 4 different counties attended a 40 hour Basic SERT training course. Supervisors from 3 different counties attended a 40 hour Basic Supervisory Course. Supervisory personnel were trained in the constantly changing laws which govern facilities. The Broome County Corrections investigations unit added 8 new investigators to its ranks. The new investigators completed an 80 hour training course conducted at the Broome County Sheriff's Office.

## Weekender Work Program 2010

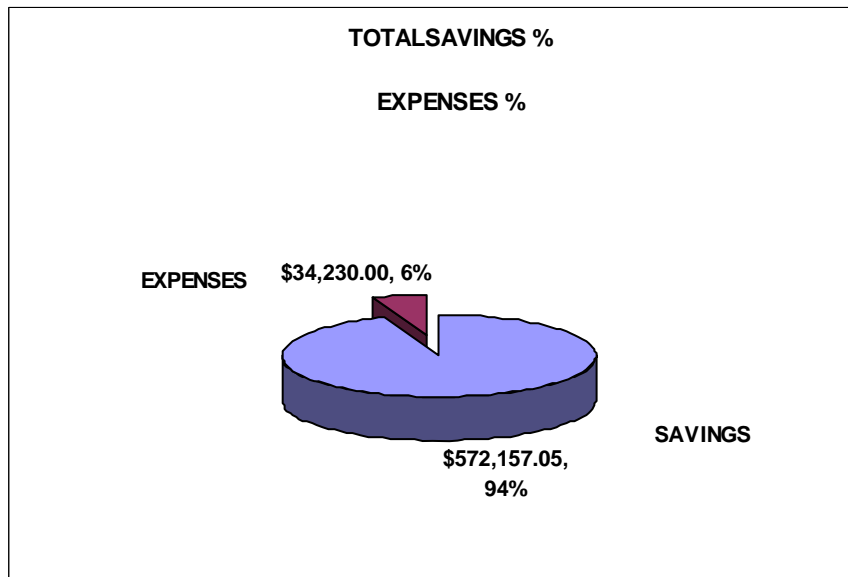
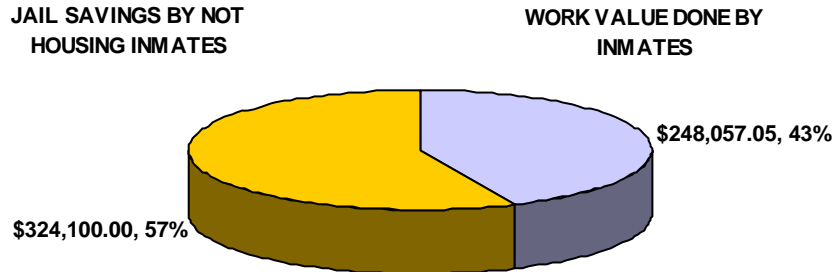
As in the past years the “8 to 4” weekend work program continues to provide a valuable asset to the Broome County community. This is done by using county sentenced inmates in community service operations in Broome County. As you may or may not know the inmates are sentenced to weekends only. They report to the Jail on Saturday & Sunday at 8:00am and are done at 4:00 pm , at which time they go home. They do this each and every weekend until the time the Judge gave them is done. When an inmate is sentenced by the court to work on the program, instead of going to jail they report to the jail and go out to work with an officer in the county. They agree by signing an agreement in court to follow all the rules given to them, or they risk being violated by the court and resented. By not having inmates in jail for lesser charges, helps save money. First by not housing them in the jail, next by not having the person lose a job that they have. The weekender work program is a program available to any “not –for –profit” groups in Broome County. By having this program it has helped put back valuable hours of labor into the community from individuals who have committed minor crimes. Most work done would never get done due to the high cost.



**Work Crew Picking Potatoes for Chow**

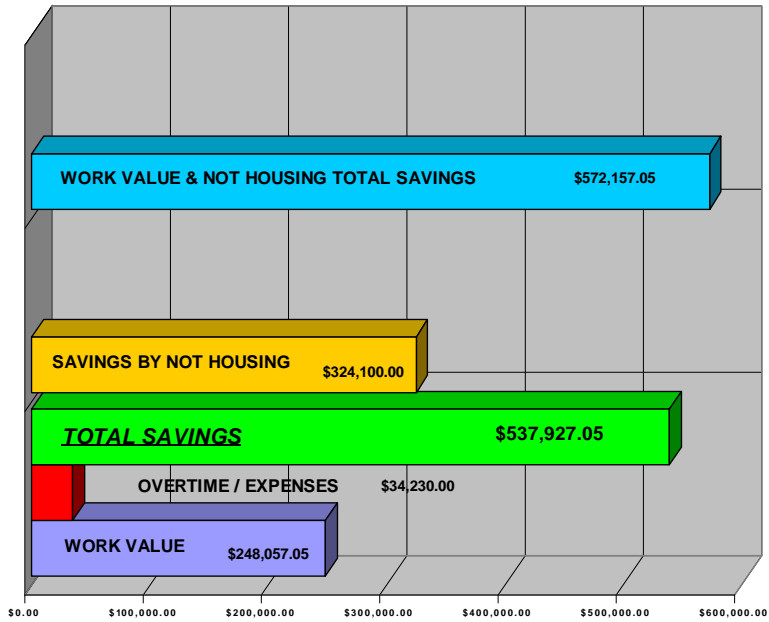


**8 TO 4 SAVINGS TO BROOME COUNTY**  
**BY CATEGORY**

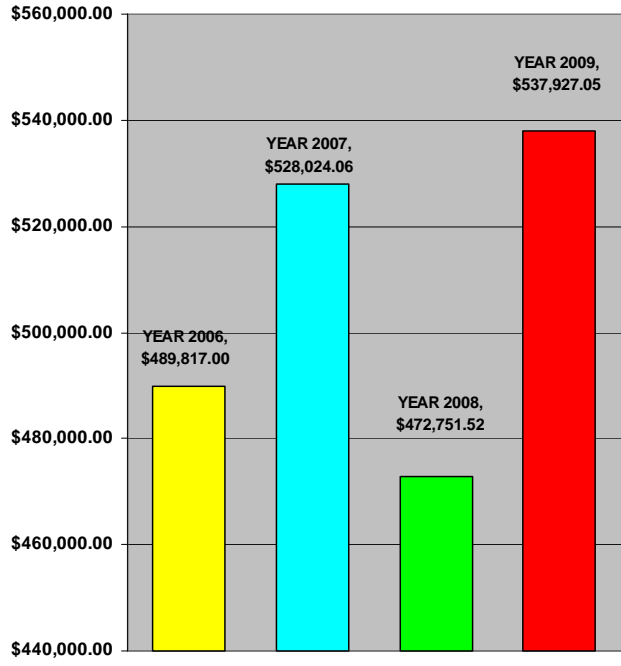


The graph below depicts the cost savings to the county by utilizing the program. By not housing the inmates sentenced to the program there is a \$324,100.00 cost savings. The work being performed is valued at \$248,057.05. This is a savings of \$572,157.05. If you subtract the overtime expenses of \$34,230.00 utilized to staff the program the total cost savings to the county for not housing the inmates is \$537,927.05. This is a significant return on a minimal investment.

# IDENTIFICATION DIVISION

The function of the Broome County Sheriff’s Office Identification Division is to maintain the criminal records from the Detective, Highway Patrol and Correction Divisions. This division is the Broome County Pistol Permit Office, issuing pistol permits to the public. Other services that are approved to the public are fingerprinting for adoptions, permits, job applications, security, clearances and other numerous types of fingerprinting needs. Another service to the public is the issuing of personal identification cards. This office also conducts record checks for many of the agencies within Broome County. The Identification Division is also the location where convicted sex offenders within the jurisdiction of the Broome County Sheriff’s Office must come to register. This office maintains a sex offender registry that is open for viewing to the public on certain levels of sex offenders. This office also conducts arson background checks on perspective volunteer firefighters. This office is staffed by the following.

- 1 – Corrections Officer
- 2 – Civilian Staff

# CIVIL DIVISION



## **2 Civil Deputies 2 Keyboard Specialists**

The Broome County Sheriff's Office Civil Enforcement Division is responsible for the enforcement of all civil processes in Broome County which include Summonses, Property Executions, Evictions, Income Executions and Subpoenas just to name a few. The Courts in Broome County and the surrounding counties depend on our Deputies to handle matters received from various Towns, Cities, Supreme, Surrogates and Family Courts. Our division often receives Orders of Protections, Summons and Petitions and other orders from all counties in New York as well as other states requesting us to affect service for them within our county.

In the year 2010 the Civil Division brought in 7,148 cases, an increase of 104 from the previous year. The Civil Division processed over 800 Summonses, 727 Evictions, 66 Property Executions and 1,916 Income Executions. Family Court services which include Neglect, Juvenile Delinquency cases, support petitions, Orders of Protection, Sexual Abuse petitions, modification hearings, and other kinds of orders and petitions totaled 2,780 services. A more detailed breakdown of the services is included in this report.

When attempting to effect service, our Deputies spend vast amounts of time investigating and locating people to be served. Incorrect addresses, names and information are given to our office and it becomes a time-consuming process to search for the correct information. Oftentimes the Deputies must send inquires to local Post Offices or question friends, relatives and neighbors of the address in which they must service. They will also investigate former employers to seek current information or research names in the office from the computer and other resources that are available to them. As a result of

their countless hours of investigation, 6,910 services out of 7,148 were served only 238 services were unable to be served; 93 services were returned either at the request of the courts or attorneys.

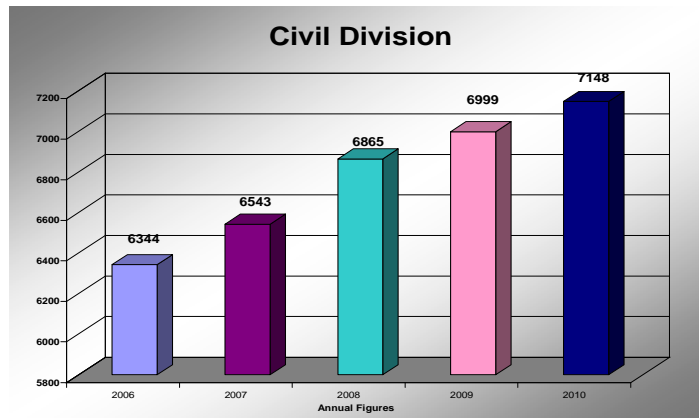
The Civil Enforcement Division handles numerous warrants of evictions for Broome County. The process for enforcing an eviction would include the Deputies overseeing the actual removal of a tenant's personal property. It would also include the enforcement of both the landlord and tenants rights and seeing that proper procedures and laws are being followed. A Deputy may spend anywhere from 1 to 4 hours and sometimes more on each eviction depending upon the situation. On the occasion of enforcing a warrant for a business such as a restaurant or an established business, our Deputies have spent 6 to 10 hours assuring the removal of equipment, furniture, and inventory.

Revenue brought in for services in 2010 was \$113,542.00 for Sheriff fees including mileage, \$148,684.72 for poundage and \$330.00 for storage fees totaling \$262,226.72. This money is all turned over to Broome County. The Civil Division took in a total amount of \$498,621.22. This includes money collected and dispersed to Judgment Creditors. In May of 2006 Governor Pataki signed a bill that increases the mileage fee charged by Sheriffs in civil matters. The bill replaced the \$0.23 mileage rate and substitutes the current federal IRS mileage reimbursement rate, which for 2010 varied between .55 cents and .50 cents per mile. Additionally anytime the IRS rate changes so will the Sheriffs civil rate for mileage. Additional legislation in 2010 brought changes to the way the Sheriff collects money on settlements on money judgments. The Sheriff can now collect on the total amount settled upon. There was also an increase on all executions as it is now required that certain notices be added and served upon all judgment debtors.

The County Attorney's Office, Real Property Tax, The District Attorney's office, the County Health Department, Support Collection and the Department of Social Services seek the Civil Enforcement Office in processing and servicing their legal process and violation notices. These county offices also seek assistance in service and procedure of Civil Law. The Broome County Sheriff's Civil Division also maintained its accreditation standards for 2009 and was Re-Accredited in July.

# **BUSINESS OFFICE**

The Business Office maintains all departmental financial functions such as Cash Receipts, Cash Disbursements and Accounts Payable. The accounts involved are Commissary/Inmate Funds, Bail & Fine Funds, Pistol Permits & Identification Funds, Records Funds and all Civil Account Funds. The staff assigned is as follows:

One Principal Account Clerk  
One Senior Account Clerk/Typist  
Two Account Clerk/Typists

The Business Office maintains the payroll records for the 235 employees of the Sheriff's Office, as well as the input, auditing and disposition of paychecks, and employee attendance records.

Worker's Compensation files and all necessary reports are also maintained in the Business Office. In 2010, the business office processed 35 Worker Compensation Claims. Of these, 6 were from Highway Patrol and 29 were from Corrections.

Purchase order and claim voucher records are maintained through an Excel program, which allows for up-to-date data needed to make necessary financial decisions. In 2010, 339 purchase orders and 932 claim vouchers were processed. The work has increased significantly (doubled) due to the new financial systems put in place in 2010 by the county.

Transactions and funds handled as bails and fines amounted to 795 and \$706,240.00.

The Business Office processed transactions for open civil accounts, of which 1,916 were new income executions and 76 were new property executions. This represents a 4.75% increase over 2009. Income executions that required additional service upon employers (generating additional fee income) amounted to 1222 cases. 1,755 cases were closed as satisfied, nulla bona's and balance nulla bona's.

The number of receipts processed in 2010 was 25,434 which are approximately 97 payments a day. Disbursements relevant to these accounts amounted to 3,074 which is approximately 256 per month. . Sheriff's fees (Poundage – 5% of all payments received) amounted to \$148,684.72. Fees generated for Income and Property Executions amounted to \$130,557.00.

All inmates and commissary funds are processed through the Business Office. Daily funds are received, deposited and posted to the inmate accounts through the Swanson

Banking System. \$520,022.23 was receipted through the inmate funds account and \$531,425.58 was disbursed. Audits are conducted using the automated system and balanced to the manual control accounts on a weekly basis. Swanson Corporation processes all commissary orders and delivers the orders to the facility. This procedure has helped diminish inventory shortages and employee expenses. Receipts amounting to \$98,413.61 were processed through the commissary funds account and \$62,276.07 was disbursed in 2010. Net sales generated from the commissary account for 2010 were \$325,865.55 and commissions from these sales amounted to \$96,945.

# RECORDS DIVISION

The Records Division of the Broome County Sheriff's Office is responsible for the recording and maintaining of all official records and documents relative to the police operations of the Broome County Sheriff's Office. This Division is responsible for entering all Incident/Case and Accident Reports investigated by the officers of the Broome County Sheriff's Office into the AS-400 Computer System and filing monthly reports to the Division of Criminal Justice Services in Albany using the Incident Based Reporting System. Personnel that are assigned to the Records Division are as follows:

- 1 Stenographic Specialist
- 1 Keyboard Specialist

The members of this Division are responsible for providing the public with copies of Motor Vehicle Accidents, New York State Incident Reports and photographs as required. In 2010, we began offering a new service where motor vehicle accident reports can be purchased on-line. Accident and theft reports are also available through the Records Office at a fee of 25 cents per page. More sensitive reports are required to be requested through the County Freedom of Information Office. In 2010, the Records Division processed 239 Freedom of Information Requests and provided over 2300 reports to several other agencies, including the District Attorney's Office, the Department of Social Services, the Probation Office and the New York State Parole Office.

Additionally, the Records Division is responsible for providing an alarm permit to the residents and businesses in our jurisdiction who maintain a burglar alarm on their premises. This Division also maintains an account of all avoidable alarms occurring at these locations, and provides billing as required. There is no fee for an alarm permit; however, fees do come into effect for excessive avoidable alarms within each calendar year. A breakdown of these fees is as listed below:

- Alarm permit ----- No charge
- First, second, third & fourth avoidable alarm – No charge
- Fifth alarm ----- \$25.00 charge
- Sixth alarm (and any thereafter) ----- \$50.00 charge each

Monies generated for the County of Broome for various services conducted by the Records Division is recapitulated as follows:

- \$ 871.00 - Collected directly by Records for reports/photographs
- \$3,500.00 - Collected directly by Records for avoidable alarm fines
- \$4,371.00 - Total monies generated by the Records Division in 2010
