Legal Aid Society of Mid-New York

Legal Aid provides free civil legal services for those 60 and older, those who are disabled, and for eligible low-income families. The agency assists seniors with simple wills, powers of attorney, health care proxy/living will, simple real estate, and consumer or income maintenance matters. The agency does not handle criminal cases, traffic tickets, real property conveyances, probate or administration of estates. The agency does not sue creditors, medical providers or others on client's behalf. For drafting of legal documents, call the Legal Aid Society of Mid-New York at 607-231-5900. For consumer or income maintenance issues, call the Central New York Legal Helpline at 1-877-777-6152.
