

## MINUTES - FIRE ADVISORY BOARD MEETING - DECEMBER 11, 2025

Call to order at 7:00 pm by Chairperson Tom Giblin.

The minutes were e-mailed out to all members. Motion by Mike Redding, second by Rob Brady, to accept the minutes of the October 9, 2025, meeting. Carried.

**EMERGENCY SERVICES REPORT:** No one from Emergency Services was present.

**BYLAWS:** The Chiefs' Association is changing their officers, they will now have two fewer directors. We will have to change Fire Advisory Board bylaws in 2026, to reflect this change.

**PREVENTION/EDUCATION:** The fire safety trailer is currently at Port Crane. We need money to get the vehicle in service and we have applied for a grant for a new generator for the trailer. Conklin Chief Bill Gorman said Conklin Fire may have a generator. He will check on it and let Rob Brady know. Triangle Chief Jason Hewitt said they may want to use the trailer this year.

**BROOME COUNTY FIRE CHIEFS' ASSOC:** Next meeting is February 5 at Triangle. They are working on a countywide rehab policy.

**BROOME COUNTY FIREFIGHTERS' ASSOC:** They are not doing well financially. For 2026, they have increased the trailer maintenance fee from \$100 to \$150 to help cover insurance and other costs. The donated vehicle, a 2013 Tahoe, needs new rims, current ones are rusty and tires keep going flat. It also needs some updates for towing and some body work. Suggested we check with Gary's U-Pull-it to see have they have these. Their Memorial Service was in October and was well attended.

**NYS AFC:** Annual seminar is Monday, February 23, at Susquehanna Valley High School. Topic is "Dangerous Spaces: Challenges and Tactics When Dealing with Garage and Basement Fires." taught by Mike Lombardo of the Buffalo Fire Department.


