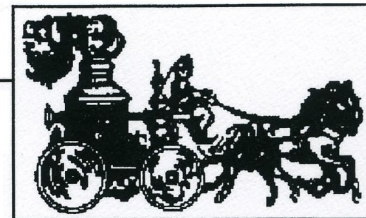

MINUTES - FIRE ADVISORY BOARD MEETING - MAY 8, 2025

Call to order at 7:00 pm by Chairperson Tom Giblin.

The minutes were e-mailed out to all members. Motion by Gil Senger, second by Mike Redding to approve the minutes of the March 13, 2025 meeting. Carried.

EMERGENCY SERVICES REPORT: Deputy Fire Coordinator Jerry Launt reported:

- Jeff Crane is the new supervisor of Communications.
- JPJ Electronics is a local vendor who will now be doing lights and siren installations.
- County officials met with Guthrie and they have agreed to do OSHA physicals rather than NFPA physicals they had been doing and to make referrals in-house.
- Vestal Fire is still having problems with the physicals. They were asked to provide information on these problems so Jeff Buckler and Neal Haight can follow up on them.
- Guthrie had said that they will no longer be doing on-site physicals, but they recently scheduled on-site physicals with Endwell Fire.

BYLAWS: No report.

PREVENTION/EDUCATION: Rob Brady reported that he has picked up the fire safety trailer from Port Crane where it was stored for the winter. The first use will be June 1.

LEGISLATURE: No report.

HAZ MAT: Nick Griswold reported that they have some new equipment including a refrigerant detector. He asked if local training was available on solar panels. There is no standardization on these and there are lots of variables in the designs, so extinguishment on these differs. Can NYSEG do training on these?

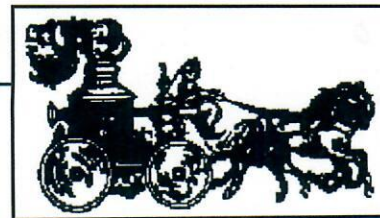
