WHEREAS, because the project is being funded, in part, with funding through the Federal Highway Administration, which requires compliance with Federal and State laws and regulations in order to obtain funding authorization; and

WHEREAS, in the course of progressing the project, the County has obtained from the Federal Highway Administration and New York State Department of Transportation authorizations and approvals of the types that qualify this project for an exemption from the EDPL public hearing requirement; and

WHEREFORE, one of the parcels that must be acquired in order to accomplish the project is an approximately 0.007 acre triangular shaped parcel situated at the corner of Tax Map Parcel No. 132.09-1-36, which consists of approximately four (4) acres of area; now, therefore, be it






