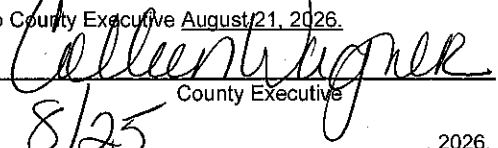

MEMORANDUM OF AGREEMENT

The County of Broome ("County") and Broome Administrative and Professional Association ("Union" or "BAPA") hereby enter into this Memorandum of Agreement in complete and final agreement on the terms of a successor collective bargaining agreement to the January 1, 2020 through December 31, 2025 agreement. This Memorandum of Agreement shall not become effective until approved and ratified by the Union and approved by the Broome County Legislature. All provisions of the January 1, 2021 through December 31, 2025 collective bargaining agreement between the parties, as extended, shall continue except as modified by this Memorandum of Agreement.

1. Housekeeping items as agreed upon by the parties including but not limited to:
 - Update language to be gender neutral
 - Incorporate existing MOA amending Article 13(1) Holidays to add Juneteenth to the listed holidays.
 - Remove Article 10, Parking Fees, Section 2, in its entirety.
 - Article 15 (1)(b) – change "workday" to "work week"
 - Article 18, paragraph 4 – Update paragraph date and eliminate paragraph 5
 - Delete Article 32, Part-Time Benefits, Section 2(f) related to parking fees in its entirety.
 - Remove Article 34
 - Add and remove agreed upon position titles
2. Wages
 - 1/1/26 – 3.75% base wage increase (wage increase will be retroactive for active employees and retirees as of 1/1/26)
 - 1/1/27 – 3.5% base wage increase
 - 1/1/28 – 3.5% base wage increase
 - 1/1/29 – 3.75% base wage increase

Minimum salaries on the BAPA schedule will increase each year of the contract 2026-2029 by the same amount as the wage increase listed above for that year.

3. Article 5, BAPA Executive Board Meetings and Contract Negotiations shall be amended as follows:
 1. The County shall recognize the fact that it may be necessary for the duly elected Executive Board of BAPA to hold meetings during normal working hours. It is therefore agreed that the County will allow each calendar year a maximum of ~~twenty-five (25)~~ fifty (50) hours total for all of Executive Board members to attend such meetings.
 2. The BAPA Executive Board members will be allowed a reasonable amount of leave with pay away from regular duties in order to carry out the functions of the Board.

Leave for the Executive Board members to attend to duties on behalf of BAPA shall not be deducted from the total of ~~25~~ 50 hours as herein above provided. Before taking such leave, the Board members will confirm their whereabouts with the Department Head (or designee), and such leave shall not disrupt the normal business of the Department(s).

3. Where there is appropriate available meeting space in buildings owned or leased by the County, it shall be available from time to time to the Broome Administrative & Professional Association for specific meetings. Requests for such space shall be made in advance pursuant to County rules for use of such space by the general public.
4. The employer will give time off with no loss of time or pay for four (4) employee members of BAPA contract negotiating committee to participate in contract negotiations.

4. ARTICLE 6, Item 2, shall be modified as follows:

Covered employees may join the Union at any time. No employees must join the Union as a condition of employment, but all employees who are Union members at the commencement of this Agreement must maintain their membership for the duration of the said Agreement. Any member wishing to withdraw from the Union may do so without penalty by notifying ~~the Business Agent~~ a BAPA Executive Board member and the Commissioner of Finance Director of Office of Management and Budget during the last 60 days of this Agreement.

The Union agrees to hold the County harmless, including all costs of such defense, against any claims whatsoever rising out of the deductions made pursuant to this section.

5. Article 7, Item 3 – Simplified Grievance Procedure, will be modified as follows:

STEP 1. The employee may discuss a situation with the immediate supervisor with or without Union representation. If the employee determines that a grievance does exist, the employee may file a written grievance with the supervisor within ~~15~~ 20 business days of the knowledge of the alleged grievance dispute. The supervisor must respond to the grievance withing 10 business days.

STEP 2. If the employee is not satisfied with the response of the immediate supervisor, ~~he/she~~ the employee may submit a written request for further consideration of the matter to the department head within 10 business days. The department head shall meet with the employee and the Union to hear the facts. The department head shall issue a decision to the parties within ~~30~~ 20 business days.

STEP 3. If the employee is still not satisfied with the response of the department head, ~~he/she~~ the employee may, within 15 business days of receipt of the Step 2 response, submit

a grievance to the Personnel Officer or designee. The Personnel Officer or their designee shall meet with the Union to hear the facts. The Personnel Officer or designee shall issue a written decision to the parties within ~~30~~20 business days.

STEP 4. If the grievance is not settled at Step 3, BAPA no later than 15 business days after a decision under Step 3, may request arbitration, under the terms and procedures of NYS PERB. Such expense as is necessary will be borne equally by the parties. The decision of the arbitrator shall be final and binding.

6. Article 9, Item 2a – Performance Step Increments, will be modified as follows:

Effective January 1, 2026 each full-time employee who is at Step 4 or below shall receive a 3% performance step annually on ~~his/her~~ the employee's anniversary date in title, provided that ~~his/her~~ the employee has received a satisfactory performance evaluation. For the purposes of this salary plan, the term “anniversary date in title” (current title or grade) shall mean the day upon which the employee assumed the duties and responsibilities of a particular title, whether on a temporary, provisional, probationary, or permanent bases, unless the assumption of the particular position is in the same pay grade as the employees previous title as reflected in the records on file in the Department of Personnel.

~~Employees hired after the ratification of this contract will receive step increases of 3% over a ten (10) year period. Those step increases will occur every other year starting with their second anniversary and occurring every other year after that for a total of five (5) steps over ten (10) years.~~

7. Article 9, Item 4, Shift differential, will be modified as follows:

- a) If a majority of an employee's regularly scheduled hours per day fall between 3:00 p.m. and 11:00 p.m., the employee shall be paid \$1.25. Beginning on January 1, 2027, the employee shall be paid \$1.50 per hour shift differential.
- b) If a majority of an employee's regularly scheduled hours per day fall between 11:00 p.m. and 7:00 a.m., the employee shall be paid \$1.25. Beginning on January 1, 2027, the employee shall be paid \$1.50 per hour shift differential.
- c) If a majority of an employee's shift falls anytime from Friday 11:00 PM to Monday 5:00 AM, the employee shall receive an additional (weekend) differential of 75 cents. Beginning on January 1, 2027, the employee shall be paid \$1.00 per hour.

8. Article 13, Item 4 – HOLIDAYS, will be amended as follows:

Employees covered by this agreement who ~~are scheduled to work~~ either the actual date or observed date of a listed holiday, or both, are entitled to float the hours worked on that holiday or observed holiday during the fiscal year and shall receive in addition to their regular pay, compensation at the one-half (1/2) rate for ~~either or the days but not both the~~

hours they worked. If the employee works on the actual holiday and the observed holiday, they will receive this compensation only for the hours worked on the actual holiday.

9. Article 14, Vacation, shall be amended as follows:

1. (REMOVE)
2. ~~Employees hired on or after January 1, 1980~~ Employees hired on or after Jan. 1, 1980 shall accumulate vacation per the following schedule: (No change)
3. (no change)
4. (no change)
5. An employee who has completed six (6) months of continuous service to the County shall be entitled to carry over five (5) days of accrued vacation. An employee who has completed one year of continuous service shall be entitled each year to a carry over of ten (10) days of accrued vacation. After five years of continuous service, an employee shall be entitled to carry over ~~twenty (20)~~ twenty-three (23) days accrued vacation without department head approval, and up to twenty-five (25) days accrued vacation with department head approval. Notification of the intent to carry over ~~two weeks~~ will be made well in advance of the end of the calendar year. Any authorized carry over days in excess of ~~twenty two (22)~~ twenty-five (25) days must be used or taken prior to any separation from employment and will not be paid at time of separation from employment.

9. Article 14, Item 11 – Vacation, will be amended by adding the following at the end of the paragraph:

Accumulated vacation time shall be received by the employee on the first of the month following that in which it was earned.

10. Article 15, Introduction, Sick Leave, will be amended by adding the following at the end of the paragraph:

Accumulated sick leave shall be received on the first of the month following that in which it was earned.

11. Extend the sick leave bank MOA referenced in Article 15(10) (Appendix J and MOA attached to the current contract) through the end of the negotiated contract.

12. Article 19, Bereavement Leave, shall be modified as follows:

1. The Public Employer agrees to grant a bereavement leave in the event of a death in the family of an employee covered by this Agreement. The employee shall be entitled, when such leave is so required, to ~~the next three (3)~~ five (5) scheduled workdays with regular pay to arrange for or attend the funeral or burial. Immediate family shall be deemed to be... (no additional change)

2. ~~With the written consent of the County Executive, an employee shall be entitled to three (3) additional days bereavement leave in reference to the above.~~ *all not CS JG*

13. Amend Article 22, Pensions, shall be amended to read as follows:

ARTICLE 22 - PENSIONS

1. The Public Employer agrees to provide Plan 75(i), ~~Plan 89 M or Plan 552 Coordinated Plan,~~ or the State retirement plan for which the employee is eligible, coverage for all employees covered by this Agreement who are eligible for these plans under the New York State Retirement and Social Security Law.

Effective January 1, 1973, all employees covered under this Agreement that retire under plan 75(i), Coordinated Plan, or other New York State Retirement Plan for which they are eligible, shall be eligible for benefits of Section 41(j) (conversion of unused sick leave benefits) as provided by law. The entire premium for this benefit shall be paid by the employer. Any employee covered by the agreement shall be paid for any accumulated sick days in excess of the maximum number of days that can be applied to the years of service for retirement purposes under New York Retirement Law. Said payment shall be at the employee's rate of pay at the time of retirement. In the event that an active employee passes away before retirement, the employee's estate or beneficiary will be paid for any accumulated sick days in excess of the maximum number of days that can be applied to the years of service for retirement purposes under New York Retirement Law at the employee's rate of pay at the time of death. ~~Employees who retire under Plan 89M or Plan 552 will be entitled to payment of unused sick days per the MOA.~~

14. Article 26, Educational Leave, shall be amended as follows:

1) ~~Employees may be granted up to five (5) hours of education leave per week to attend job-related classes. Each year a BAPA financed fund of \$5,000 will be established for the purpose of reimbursing employees for the cost of books, fees, or other miscellaneous expenses billed to the student by the education institution when they are enrolled in tuition only for job-related coursework. Such courses~~ The coursework must be credit bearing and shall directly affect the employee's current job or career development within Broome County. Reimbursement will be based on the attainment of at least a grade of C or better. In order to ensure all members have equal access to the education fund, reimbursement will be distributed at the end of January of the following year from which expenses were incurred. If necessary, distribution will be on a prorated basis and will be based on the amount requested for reimbursement by each member. Requests can be submitted at any time throughout the year to the Treasurer but must be received no later than January 15th of the year following that which the expense is incurred.

2) Employees may be granted up to five (5) hours of education unpaid leave per week to attend job-related classes. Application for Education Leave must be made on forms supplied by the

Department of Personnel and bear the approval of the Department Head before it is fully submitted to said Department.

3) ~~The Association~~ BAPA will be allowed to spend up to \$1,000 of the amount in the ~~tuition~~ education reimbursement fund for BAPA employees to sponsor in-service training in a related area of management and professionals; attendance will be encouraged by the County. This training will be open to any BAPA member.

15. Amend Article 31, Effective Dates, to reflect the term of 1/1/26 through 12/31/29.

16. Article 33, Item 1, Payroll, will be amended as follows:

1) All payroll errors either in the employees or County's favor shall be corrected as soon as they are discovered. Errors in the County's favor of \$100.00 or 6% of an employee's normal biweekly gross pay (whichever is less) ~~would~~ will be eligible for given as a payroll advance. The County will process and submit the payment within two (2) business days of the notice of the error. Errors less than this will be corrected in the succeeding payroll cycle. Those errors that have been continued from some past date shall only be corrected one (1) year retroactive from the point of discovery.

17. Amend Article 33, Payroll, by adding a new section 3 to read as follows:

3. Effective [RATIFICATION], all employees will be paid via direct deposit only.

Employees that convert to direct deposit will be furnished upon request with a printed pay stub. This paragraph terminates upon the expiration of the collective bargaining agreement.

18. Article 36, Uniforms, shall be modified as follows:

1) Any employee who is required by ~~their~~ the employee's Department Head to wear a uniform in the performance of ~~his/her~~ the employee's job duties shall be provided with a sufficient number of said uniforms at County expense or shall be paid a uniform allowance of ~~\$250~~ \$350 per year. ~~This will increase to \$300 effective January 1, 2017.~~

2) For applicable members who are required to wear protective footwear (steel toe boots, work boots, safety toe boots) or prescription safety glasses, the County agrees to reimburse the employee up to \$400 annually for the purchase of approved protective footwear and up to \$200 annually for the purchase of prescription safety glasses. Employees must demonstrate that the purchased protective footwear are ANSI/OSHA/PESH approved.

3) BAPA employees assigned on a temporary or occasional basis to perform work ordinarily performed by uniformed employees shall either be provided with uniforms or

with appropriate protective outer clothing. The decision to provide uniforms or pay the allowance will be made by the Department Head.

19. Article 37, Drug Testing, will be modified as follows:

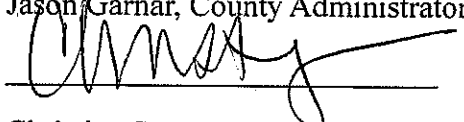
Effective January 1, 2007, all employees of the Security Department shall be subject to the same Drug and Alcohol Testing Policy as the Broome County Sheriff's Office, including pre-employment and random testing.

Effective January 1, 2027 all employees hired within the Probation Department to a job title required by the Department to carry a firearm shall be subject to the same Drug and Alcohol Testing Policy as the Broome County Sheriff's Office, including pre-employment and random testing. Employees in the Probation Department who were hired prior to January 1, 2027 within the Probation Department in a title required by the Department to carry a firearm will be able to opt out of carrying a firearm. If such employees opt out of carrying a firearm, they shall not be subject to testing in accordance with the Broome County Sheriff's Office Drug and Alcohol Testing Policy for THC/marijuana and/or alcohol.

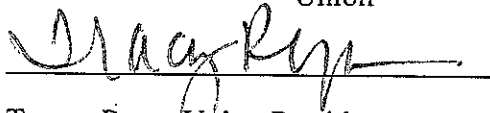

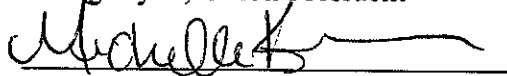
