

PUBLIC SAFETY & EMERGENCY SERVICES COMMITTEE MEETING MINUTES  
MARCH 7, 2016

**#32 RESOLUTION AUTHORIZING RENEWAL OF THE AGREEMENT WITH BI INCORPORATED FOR ELECTRONIC MONITORING SERVICES FOR THE DEPARTMENT OF PROBATION FOR 2016**

Responding to a question from Mr. Heebner, Ms. Wilmot explained that the increase is due to using more units for the Juvenile Pretrial Release Program. Responding to a question from Mr. Baker, Ms. Wilmot stated that this service did not go out to bid and that this company charges them only for units that they use.
