Following the Resolutions, Mrs. Boulton stated that there were only two respondents to the DPW Survey Services RFQ, Hulbert Engineering and Shumaker Engineering, both of whom are the current contract holders. Answering two questions from Mr. Pasquale, Mrs. Boulton stated that while reissuing the RFQ could result in more responses, she doesn't believe it would, and that both firms as current contract holders are more than qualified to hold the contracts. Mr. Baker made a motion, seconded by Mr. Baldwin to forgo interviews and recommend both Hulbert Engineering and Shumaker Engineering for the DPW Survey Services Term Contract. Carried. Mrs. Boulton mentioned that there are LSDA interviews that need to be conducted for the County Road 20 (CR20) a/k/a Kirkwood Conklin Road Bridge Project. The Committee agreed to hold those interviews at the June Public Works & Transportation Committee meeting.

Following those discussions, the Committee went at ease at 4:24 PM in order for the Committee to undertake the consultant interviews for the DPW Facilities Engineering Term Contract.

The Committee reconvened at 6:01 PM following consultant interviews. After discussion, Mr. Baker made a motion, seconded by Mr. Baldwin, to select Chianis Anderson & McFarland-Johnson Team and Delta Engineers, Architects & Surveyors for the DPW Facilities Engineering Services Term Contract and rank the firms as follows:
