RESOLUTION ADOPTING LOCAL LAW INTRO. NO. 3 OF 2012, ENTITLED: "A LOCAL LAW AMENDING CHAPTER 214 OF THE BROOME COUNTY CHARTER AND CODE TITLED FEES AND CHARGES"

WHEREAS, this County Legislature pursuant to Local Law Number 5 of 2010 Chapter 100 of the Broome County Charter and Code titled "County Roads, Hauling On" which provided for the issuance by the Commissioner of Public Works of special hauling permits to operate or move a vehicle, or combination of vehicles, on and over county highways, the weights or dimensions of which vehicle or vehicles exceed the limitations provided in §385 of the New York Vehicle and Traffic Law; and

WHEREAS, the Commissioner of Public Works has requested this County Legislature establish fees for the issuance of said special hauling permits, now, therefore, be it

RESOLVED, that Local Law Intro. No 3 of 2012, entitled "a Local Law Amending Chapter 214 of the Broome County Charter and Code Titled Fees and Charges" be and the same hereby is adopted and approved in accordance with the Broome County Charter and all the applicable statutes and laws pertaining thereto.

LOCAL LAW INTRO. NO. 3 Of 2012

"A LOCAL LAW AMENDING CHAPTER 214 OF THE BROOME COUNTY CHARTER AND CODE TITLED FEES AND CHARGES"

BE IT ENACTED, by the County Legislature of the County of Broome as follows:

Section 1. Chapter 214 of the Broome County Charter and Code is hereby amended to add:

ARTICLE III
Special Hauling Permit Fees.

Section 2. **§214-3. Fees and charges.**

The following fees and charges are established for the issuance of a special hauling permit as follows:

<u>A. One truck making one trip</u>	<u>Administrative Fee</u>	<u>\$100.00</u>
	<u>Permit Fee</u>	<u>\$ 10.00</u>
	<u>Total</u>	<u>\$110.00</u>
<u>B. Road Maintenance Agreement *</u>	<u>Administrative Fee</u>	<u>\$100.00</u>
	<u>Permit Fee</u>	<u>\$ 10.00</u>
	<u>Total</u>	<u>\$110.00</u>

*** Pursuant to §100-4 of the Broome County Charter and Code the issuance of a Road Maintenance Agreement shall be subject, in addition to the permit fee, to such additional terms as may be reasonably required by the Commissioner of Public Works.**

Section 3. This Local Law shall become effective on March 1, 2012 and upon filing with the Secretary of State.
