#### **PUBLIC OUTREACH**

Public outreach is an important element of the comprehensive planning process. The Town of Sanford conducted a public survey from January 2018 through March 2018. Through this survey, the Town solicited input satisfaction with Town services, desirability of developments, levels of concern for various issues facing the Town, budget priorities, support for agricultural initiatives, qualities people value, and issues the Town should improve upon. were mailed to property owners and the public was encouraged to participate through a Deposit Courier press release. For those who may not have received a survey in the mail, additional copies were available at the Town Hall, and the survey was open to public online. A total of 418 surveys were completed, representing a 29% response rate. Survey results were used to inform the plan and many of its recommendations.



#### **POPULATION GROWTH**


Sanford residents indicate they do not want the population to change significantly. When asked how the residents would like to see the population change, about half (51%) would like to see some slight growth, and 27% would like to see it stay about the same. One out of five residents would like the Town to grow significantly, and 2% would like the population to decrease.


How would you like to see the Town's population change over the next ten years?



#### RESIDENTIAL DEVELOPMENT

While most of Sanford's housing stock consists of single-family homes, respondents feel other types of residential development are desirable in the town. Out of the given choices, the majority favor senior assisted living and seasonal homes; more than 80% find these residence types either very or somewhat desirable. Many respondents feel individual mobile homes (48%) and mobile home parks (74%) are not desirable in the Town of Sanford.






#### **COMMERCIAL DEVELOPMENT**

Overall, Sanford residents favor most types of new commercial development. The most desirable types of commercial development include restaurants and agri-tourism, over 90% of residents indicate these are either very or somewhat desirable in the town. Less favorable developments, where the majority of respondents feel uses are not desirable, include heavy industry (high-intensity manufacturing, processing, and chemical refining uses) (61%) and high-volume hydrofracturing (51%). A larger percentage of South Sanford residents feel fracking is not desirable compared to the rest of the Town. There were no major differences of opinion between full-time and seasonal residents.


## How desirable are the following types of new residential development?




#### **TOWN SERVICES**

A variety of government services are provided to residents and property owners in the Town of Sanford. Respondents were asked to rate these services; this can identify areas for improvement. Generally, residents feel they receive an excellent or good level of service for most individual services. There is an opportunity to improve road maintenance and ambulance services; nearly a third of respondents (31%) indicate these need improvements. A large portion of residents had no opinion on dog control services.

In North Sanford, 38% of respondents feel road maintenance needs improvement. In the Village of Deposit, more than 50% of respondents feel ambulance service needs improvement.






#### **COMMUNITY CONCERNS**

The survey asked about concerns for the future of Sanford. Overall, most residents share some level of concern for all choices provided. Economic concerns emerged as a priority issue. Residents' primary concerns include increasing taxes, loss of farms, illegal dumping, and declining home values. New growth and development were the lowest ranked concerns. Respondents are typically less concerned about increasing residential development, impacts of large-scale solar, and increasing commercial/industrial development.

#### **DRINKING WATER**

Water quality is an important priority for Sanford residents. Most residents experience no quality or quantity issues with their private water well. Several respondents noted their water is provided by the Village of Deposit, so this question was not applicable to them. If respondents had issues with their private drinking water wells, more often it was related to water quality (16%) than water quantity (5%). Residents in West Sanford reported higher rates of water quality issues compared to the town average.

Do you have any problems with you private drinking water well?




#### **REGULATORY CONTROLS**

Regulatory controls exist to help the town achieve broader, long-term visions. Many residents feel Sanford's land use laws and code enforcement are just right. About 20% of residents feel code enforcement is not strict enough, whereas 12% feel land use laws are not strict enough. Approximately one in ten people feel these controls are too strict. Almost a third of residents have no opinion about these types of controls, and some noted they were unfamiliar with the Town's local laws.

#### **LIFE IN SANFORD**

Perceptions of quality of life among residents strongly affects the decision to move somewhere. Overall, residents have a positive view of Sanford. Most residents are either very satisfied or satisfied with living in Sanford; only 5% are dissatisfied. Nearly three-quarters of all respondents would recommend someone to move to Sanford. About 71% state they would recommend a friend/family to move to Sanford, while 13% indicate they would not.

Overall, how do you like living in Sanford?



Would you recommend a friend/family to move to Sanford?






#### **BUDGET PRIORITIES**

Every community must decide the best way to utilize public funds. When asked how to allocate funds, residents assigned points primarily to actions that would improve the look/appearance of the town (26%), and efforts to protect the environment and agriculture/open space (24%). The smallest portion of funds were allocated to special programming (13%) and parks recreation (12%) activities. The highest ranked individual categories include protect air and water quality (12%),protect/promote farms and agriculture, including agri-tourism (12%), and maintain existing infrastructure and services (12%).

#### **AGRICULTURAL INITIATIVES**

The results indicate strong support for agricultural development in the town. Over half of the respondents think each of the initiatives should be supported by the town. Especially strong support was for agricultural tourism (87%), or agri-tourism activities, followed by specialty farming including hops, hemp, beekeeping, etc. (83%), and greenhouses/Christmas tree farms (82%).

#### **COMMUNITY ASSETS**

Knowing what assets are valued by the residents can help the town understand reasons why people choose to live in Sanford. Most frequently residents said Sanford's assets include scenic beauty, rural character, and natural resources. Not surprisingly, these coincide with what most residents think should be prioritized in the town's budget.

#### **COMMUNITY SHORTCOMINGS**

Understanding community weaknesses from the residents' perspective can help the Town identify opportunities for improvements. Overall, lack of development and/or jobs, increasing taxes, and poor building appearance were identified as the Town's shortcomings. These results relate to many of the concerns residents identified with in a previous question, as well as those who feel Sanford's code enforcement is not strict enough.







#### **WRITTEN RESPONSES**

In addition to the questions asked in the survey, respondents had an opportunity to provide extra feedback, comments, ask questions, etc. in an open-ended question. Over 100 respondents used this opportunity to further inform the plan. A word cloud was generated using the responses. Written responses can be found in the Appdendix.



#### **SURVEY PARTICIPANTS**

As previously stated, over 400 survey responses were included in the results. Respondent information was collected to ensure the results were representative of the town as a whole.

Most of the surveys (50%) were completed by full-time residents of Sanford, which includes Village of Deposit residents. With 42% indicating part-time residency, seasonal residents are well-represented in the survey results. Less than 10% of the surveys were completed by those who are not residents of Sanford, but may own property within the town.

A large majority of surveys (87%) were completed by those who have lived in their homes for at least ten years. Most participants (61%) have lived in their homes for 20 years or longer. This is consistent with Census data trends.

The majority (51%) of surveys were completed by those 65 years or over, followed by those between the ages of 45 to 64 (41%). Less than 10% of the survey respondents were under the age of 45. The age breakdown of survey respondents is slightly skewed towards older populations, compared to the actual age distribution of the town.

The geographical distribution of residents was relatively balanced. The largest percentage of respondents reside in South Sanford (27%), followed by North Sanford (24%). The smallest respondent group was East Sanford (14%).



These locations are examples of maximizing their natural resources with conscientious government planning and oversight.

In regards to #8 Code Enforcement Law is OK but needs to be enforced.

Some questions have too many options contained in the one question. NY State property taxes (especially school taxes) are way too high. This area has some of the most beautiful countryside anywhere. It is the messed up government (especially the state government) that drives people out of the area.

Some of us worry about Town of Sanford board members that own large amounts of property making decisions that may benefit themselves, relatives, and friends instead of what's best for the Town of Sanford. I guess you might call it a conflict of interest.

#### Q2. Fracking desirable in some places if away from Oquaga Creek

I am encouraged by the creative list of opportunities for out Town that include 'agri-tourism', bike trails, better walkways. I have often seen groups of tour buses- often Asian tourists or those from the South of the USA, stopping at fast-food places outside of Binghamton, and believe those visitors would LOVE the opportunity to be introduced to our working farms. I once brought the suggestion to a few community leaders in Deposit to take the old Agway/Borders Creamery building and make it into a museum to our local dairy industry. I even started getting some large glass Borders milk bottle. The tall chimney that is the only remaining part of the structure is the most underutilized opportunity for tourism, no matter what the cost of rehabilitation, should be a marker. Of course I may have missed that it is already down. I believed that not only would such a museum be exciting but the venue could be used as an event site AND a dairy food/ice cream bar providing needed jobs for out teenagers. I also thought the inclusion of a 7th Broome County carousel, but this one, which could be in the new community park could have cows rather than horses as a unique tourist feature. The plan preceded the fire which destroyed the building. The considerable historic preservation funds, Federal and State. But alas, timing is everything.

8. The man who fills this position has his powered weakened by the Supervisor. His monthly reports are extremely limited (at least what he reports in the public portion of the Town of Sanford Board Meetings). I think our community member are what makes Deposit and Sanford a special place to live. We are sometimes blindsided by board members and Town of Sanford Supervisor by not being included in activities that affects our health and future. If there is a plan to 'force' the Town to open up their activities with website access to the public, it would be a huge area of neglect that would be corrected. We definitely need more openness in the Town of Sanford.

Need term limits on local politicians. More attention to local politicians conflict of interests when making decisions.

My interests/hopes for Sanford are to maintain as much of the unspoiled character/resources/beauty while recognizing the reality to have to generate sufficient viability and economy to survive (as a Town). Measured, careful growth and stimulation without damaging the beauty and surviving resources we still have here since settlement.

Never see or hear about things going on in the Town like clean-up days. Poor ambulance service. Poor animal control personnel. Never see elected officials or people running for office; when do they meet? What is the Town doing to help the people? I never knew that we has a Plan committee, let alone who is on said committee. What else does the Town do or have that we do not know about.

Would like to see established hydro-fracking that would jump-start economy. Gov. Cuomo's idea of increased jobs and tourism is to allow a fully-operated casino. How is that working out? Election jitters made governments decisions to put a hold on fracking. So now Mr. Cuomo is turning to 'wind power'. Whose getting bankrupted by this? Let's open up the area to gas rigs if we are going to allow huge windmills that dot the landscape.

#### Fracking- oh hell NO

5-Planning Board uses judgement for a lot of choices. 8-code enforcement good job.

My family has owned property on O'Brien Road since 1954. Most of it is woodlot and small ponds. We enjoy the clean environment and were concerned about fracking or a gas pipeline that would disrupt the natural environment. We recognize the increasing development and expanding population. We hope that a balance between rural and small town living will benefit the Town of Sanford and retain the positive aspects of this area.

I believe one of the Town's biggest assets is farming. I feel increased farming should be encouraged but only in a manner that is not harmful to the health and well-being (absolutely no harmful pesticides or herbicides, no growth hormones and antibiotics in animals raised for market). Chemical-free produce. I feel promoting solar and wind in an agricultural area like Sanford is counter-productive to farming. The same for ATV parks. Let's preserve the Town's natural beauty and openness.

Roads need to be better taken care of like when salting for ice. When you cross from Deposit to Sanford you can see a difference. Sanford is not as good for salting/plowing.

I regret not moving to the Town in 2008! Now advanced age (89) makes such a move not practical. The response when my wife was stricken was wonderful.

I own a seasonal cabin. Love the area and people. My road is in good shape and is always being worked on. Crime seems low but (as you know) area need jobs. Most upstate NY towns are experiencing the same problem. Fracking can answer some of that problem, but as a trout fisherman who loves the Delaware River system; fracking gives me great concern.

Would love to see restaurants, medical facilities, hotel/motel, bed and breakfasts, solar/wind farms; no tax breaks given. More single-family homes. Increase population and revenue = lower taxes (I hope). Thank you.

I would like to know about the Town of Sanford tax-wise that the boundary for my home the line goes through my property on 10% and 90% is Delaware and the postal is Broome and why when Delaware County has the property of property why my bill is extravagantly expensive on the Sanford or Broome side tiny portion. Delaware is extremely low. Why am I paying both counties!!

Highways/Roadways- Planning needs to be done. Too haphazard on what gets done i.e who lives where vs. high traffic areas.

Too many problems if ATVs are allowed on state land i.e. noise, safety, fires, garbage left behind.

I can't get up there because of health reasons nowhere to go for doctor care if I got sick need hospital or health care office or center.

11- My answers reflect what has worked with other areas similar to Sanford to increase their economy and livability. Some of the niceties and extras residents might desire should be considered only after the local economy can pay for them.

I am not a resident of the Town of Sanford anymore, but I do own property in the Town of Sanford.

We already have many empty homes. 6. very upset that residents pay almost \$1,000/year to have water/sewer!!!!!! 9. We need more business, work opportunities. 14. Water/sewer expense is a shortcoming. Our biggest problems are: 1) No work 2) Inability to buy locally 3) water/sewer bill.

Please talk to them and change to reduce the water level and yield.

We own 20 acres of land enjoy going up on weekends, although we've been broken into two times. Laws are too strict. Also, if you opened up drilling in NYS would prosper. Its depressing driving seeing storefronts closed. Get rid of Gov. Cuomo and the economy will prosper. We considering selling the property and buying in PA.

#### 14. High crime rate is a shortcoming

Jobs are needed for our youth, hopefully they could stay in the Town and stay off drugs. We need more commercial stores. Help them stay in business with job creation. More events to bring in visitors. I have two properties; one a rental and one vacation home. Biggest problem I have is cost of sewer and water for my rental and taxes for the village.

Most of these questions refer to the Town of Deposit- the rural community are not subject to many of these questions.

6- We get our water from the lake for watering etc. not for drinking. The pipe providing our water goes under the road. I'm concerned if any line is dug under the road that it will unearth our water line. If it cuts our water line we will have big problems!. Code enforcement needs to be equal or fair.

Front St needs restoration, empty storefronts should be temporary art galleries. Lack of building and code enforcement, dilapidated homes should be removed. All dead 'snag' trees in village removed immediately, hazard and unsightly.

6- we have spring water delivered.

Seasonal residents are the key to bringing tourism and money to this area. The people here are lovely but it is very difficult to access lodging, good restaurants, produce, cheese, wine, bread, homemade goods, bakeries, etc. There are a few treasures in the area but no advertising. We learn word of mouth about lovely places to spend money. We know families who drive 20 miles to an increase shop or a restaurant. Utilize seasonal residents!

- 6- Have has sulfur in water since I dug well 10 years ago. This area is dying due to people on planning boards etc. who do not care about progress, jobs, and the local people in the area. Crime rate is severely increasing.
- 6- Water quality problems after they put in pipeline. ATVs and 4-wheelers run the main roads on weekends and they scare livestock; we call State Police and Sheriff's Dept. all they do is give out warnings. Town of Sanford road supervisor puts a 12-inch ditch right in front of my steps and left it that way the least he could have done is put a slous pipe there. Me and my wife both use canes to talk if we get hurt over his stupidity it will make a good injury case. I have lived here for over 40 years and there has never been a ditch there since I have lived here.
- 12- Yes beekeeping, organic farming, no hops or hemp. Trim trees on banks and sharp corners where school bus signs have been put up. It's safety for the kids getting on these buses. Drivers can see a lot better if the trees were out. A child's life is work more than a trees lifespan.
- 6- I have paid significantly to correct water issues at my home.
- 5- solar and wind would be good to bring jobs to area, needed jobs. 6-I have no well, a spring flows on property. I believe we need more local jobs. As you see, the solar, wind, electric projects would be good for jobs. It was a terrible loss when Chestnut Inn closed. Probably high taxes. Even my 1.25 acres lot with minimal improvements cause the taxes to increase too much. Taxes in NYS are too high. This causes poverty, and land values to decrease.
- 3- NEVER!! high-volume hydro-fracturing (fracking)

I would like to see some of the things that I wrote down happen, but I know I won't in my lifetime. Just try your best to get some growth in the Town OK?

I come up here to get away from the cellphones, so no more towers please.

Development of the Town of Sanford would greatly benefit from the fracking of natural gas. Fracking of natural gas would bring job opportunities, development of residents and larger community development of local businesses.

Clean industry and recreation/tourism would be ideal areas of growth

Both with the assets and the shortcomings, it is difficult to select just 3 because so many of the choices are inter-related - for example - the 'sense of community' and 'people and activities' are very similar - as is 'lack of services for seniors' and 'lack of access to medical services' - as seniors often need the most medical attention. Good luck and I look forward to action being taken by the comprehensive plan committee.

I suggest that the Town of Sanford create a Trust Fund to be used on local improvements such as a building for Sr. Citizens. Fund raisers, donations from local businesses as well as estate gifts would provide the monies. In the case of large personal donations the name and amount would be provided in the memory of that individual. Designation amounts would be determined for each project.

Although we are currently seasonal residents, we do plan to, one day, become permanent residents (in the distant future).

4- from my own experience, if you need police... call the sheriff, calling troopers is a waste. 2- what are starter homes? less hassle from planning and code enforcement.

Allowing people to continue using their properties as defacto junk yards will impede any progress the town hopes to make. We have attempted numerous times to have the issue addressed to no avail. Additionally, the town needs to work with the village to attract and retain business as the village resembles a ghost town.

Poor upkeep of current homes in the area. Need better medical and emergency care. Real lack of new development.

Certain roads need to be better maintained, mostly less traveled roads which have several potholes. Snow Plowing also needs to be improved on many roads. Crashes have occurred because of the lack of salt and plowed areas.

I think that every town always needs work to be done.

8-Would you relocate to an area that looks like Tobacco Road? I am very concerned that code enforcement in Sanford is not addressing the residents' concerns about code violations. Junk vehicles littering the area impacts the economic and social viability of Sanford. The importance of good code enforcement cannot be stressed enough.

6- Have filter on main line. We need more industries; our children wouldn't have to commute or stay in Binghamton, JC, or Vestal. We are losing a generation.

Could a marketing campaign be run to attract employees to relocate, even it just seasonally, that are remote workers who can work from anywhere. The low cost of housing could be attractive, combined with recreational offerings. Could a benefactor be attracted to set up a good charter school in the area to provide top notch education?

Don't be afraid to be different. Thanks.

There has NEVER been any cellphone service on my property since we purchased our property over 10 years ago. We could like a cell tower installed. Cannot reach anyone in case of emergency. This is very bad.

Our neighbor has so many old junk cars and a lot of garbage on the property. The appearance is not pleasant to the eye. The buildings on the property are in bad shape.

9- Taxes are too high. Parts of the town look run-down. No one seems to take pride in their homes. You go to other local towns i.e. Sidney, Unetego, etc. and their homes/properties are very well-kept. Also need to develop new business opportunities--encourage new growth.

Taxes are too high! We pay for services we don't receive (Broome County Transit, Broome County Sheriff). We get terrible cellphone service. We can't get off-air channel signals (local tv). Our streams need to be cleaned, we are losing a lot of land. Our road (Old Route 17) is barely maintained, they do a horrible job plowing recently. They have not paved or widened the roads in years. W have ditches that need to be fixed, and driveways have a lot of run-off creating big patches of ice. Bridges on Old Route 17 that have not been fixed in 30+ years. The one bridge closest to our house has a hole in it, you can see the stream through the hole. Another area is across from the propane tanks, the stream is next to Old Route 17 and there is no guard rail. Need decent jobs that pay, not minimum wage ones.

Our home in Sanford is a second home, not our primary residence, therefore we are not fully aware of the towns shortcomings.

I am very concerned about the proposed wind farm. It will have a negative impact on the area. Home and land values will go down. There will be excessive noise, light flicker, and the aesthetic beauty of the land will be ruined. There is also the problem of wildlife being driven off. Birds and bats being killed in the blades of the windmill. Windmills also leak oil and need to be cleaned with harsh chemicals all this will leak into the ground water. As I understand it, the amount of usable electric produced is not worth the sacrifice of our land and way of life.

3- NO! NO! NO! (Fracking). We need Fios.

I would like to see the development of Sanford's natural gas resource. The additional revenue would greatly help all landowners and residents whom aren't landowners.

The Plan Committee must: Think beyond recreational activities and tourism which is seasonal and doesn't support the economic needs of the community year-round. Promote development that creates long-term job opportunities and brings qualified professionals to the area like teachers, doctors, dentists, and other support personnel to raise quality of life for all residents.

High-speed internet is the 'new' infrastructure that would lure younger generations to relocate whereas many people now work from home. No one with professional skills will move to an area without it. If the Town had the best, word would spread and an influx of people would relocate here.

Although the town was built on the lumber industry, shopkeepers can't survive on a few days of lumberjack festival that few outside of the area even know about. They need a constant supply of outsider tourist money generated by things like fishing, gold, hiking, winery and brewery tours, apple and pumpkin picking, Christmas tree farms, good restaurants, farmer's markets that sell items like fruits, vegetables, baked goods, pies, honey, maple syrup, arts and crafts to name a few. Most important, they need clean, quality hotel/motel rooms within walking distance to these activities in a clean, safe town with ample parking and walkable streets. There seemed to be only negativity regarding the river as a thing that sometimes floods but towns such as Roscoe see their rivers as premier fishing spots. Let's also capitalize on agri-tourism and make out town a place people would like to visit.

My family has owned property in the town of Sanford for almost 70 years, and over the years, I have seen more and more land being developed taken away for housing or small business operations such as sawmills. I would like to see the rural character maintained which is why I think that recreational parks, nature trails, and building up outdoor tourist attractions would maintain the character of the Town. I have also noticed that there are more and more people who keep dogs in what I would call heartbreaking conditions, and so I hope that better animal control would be able to address animal abuse issues. As someone who is considering retirement, it concerns me that medical services and other senior services are difficult to access, and may force me to move elsewhere even though I love the rural character of the area. I also think that people are very attracted to events that offer a combination of good food, music, and quality crafts and artwork. Those kinds of little festivals/events are lacking. In addition, encouraging maple syrup production would be a huge resource and attraction for the area. There are several maple syrup producers in the Bainbridge and Green areas, but I do not know of maple syrup producers in the Town of Sanford.

The town should make efforts to significantly curtail or actually reduce (if possible) the number of trailer homes. Few things lower property values and hurt the general appearance of an area as much

as trailer parks and trailer homes. No one wants to be near a trailer park or have trailer homes near them.

- 8- Code enforcement is very complex position. Would like to see more enforcement in terms of junk yards. We need more industry to create jobs and help lower taxes. Many of Deposit residents commute to Binghamton and the Triple Cities for work. We need to encourage industry for our area.
- 3- Fracking not desirable at all! The rural character, scenic beauty, clean air and water are by far the Town of Sanford's most precious asset and must be protected at all costs. More industry is not the answer here- especially hydro-fracking! Most new businesses claim that their biggest problem with setting up business here is getting people are here to work. So I don't think creating more jobs for people who don't want to work is a solution. I do think that maintaining the rural character, having more to do for the increasing number of people who come here to enjoy the area, and focusing on the Delaware River and the Cannonsville Reservoir and the lakes/streams and access to them. That benefits the people living here full-time as well.

It would be great if we had a super Walmart and Costco, BJs and for sure a hospital this way. We would have more jobs and it will help build back out community self-worth. I would love to be on your committee. Thank you.

During the summer and spring time volunteers should participate in beautifying the housing, especially elderly ones whom needs help in that regard. Fee applied to homeowners who do fail to maintain houses appearance especially from yards on exposed part of property. Pick up your junk!

7- I am not familiar with them (land use laws) where do I find them? 12- If fracking is limited or non-existent, then amplify the farming and agricultural opportunities.

Most of the shortcomings in the Town of Sanford are mandated by Albany. If you want fracking, the state has already said no, for an example. The city of NY and Albany regulate what is done here.

Poor road conditions, no cellphone service or high-speed internet.

More reliable emergency ambulance services for advanced age seniors. Are voluntary ambulance services the only system? Can there be planning/coordinating with Binghamton services for speedier responses? For the past 20 years, I have lived in Florida from November to May only.

4- We get no road maintenance at Deer Lake, yet we pay more taxes. 6- Water smells like sulfur. 9- We get almost no services at Deer Lake; no road maintenance, sewers.

When coming into Town from Exit 84 the appearance of buildings on left side of road does not give a good impression of the Town.

Deposit/Sanford needs restaurants and shopping and have to go to other towns. Taxes; live in Sanford and pay Afton taxes. More social for seniors and children.

We should allow fracking it would give the area much needed revenue.

We need an Aldi's grocery store in northern Sanford since the Afton Great American closed!

Look at Binghamton - is DEAD!!! Organic agriculture and tourism. Help development of organic farms, all kinds. Put in trails - dirt bike roads - ski slopes. Encourage all kind of outdoor sports, including fishing and hunting. In other words, have the people come in, spend their money, and then go home. Plan some touristic centers, organic markets for farmers with designated market days. Encourage farmers to sell their own product.
