<u>Deposit Man Facing Multiple Felonies After Fleeing Sheriffs on Stolen</u>
<u>Motorcycle Across Broome, Chenango and Otsego Counties</u>

(DEPOSIT, NY) A Deposit man is facing felony and misdemeanor charges after fleeing Broome County Sheriff's Road Patrol on a stolen motorcycle through multiple towns, villages and counties.

On Saturday, November 15, 2025, at around 7:53 PM, members of the Broome County Sheriff's Office Road Patrol observed a motorcycle traveling at a high rate of speed on Second Street in the Village of Deposit. When the deputy attempted a traffic stop on the motorcycle, the operator failed to comply, sped up and led the deputy on a pursuit on Old Route 17 out of the Village of Deposit and into the Town of Sanford.

BCSO Road Patrol continued pursuing the vehicle through the Town of Windsor, with the motorcycle reaching speeds between 65 mph and 90 mph and crossing lanes into oncoming traffic as it attempted to escape. After reaching the Village of Windsor, the motorcycle continued northbound on Route 79 into the Town of Colesville, where it turned east on Route 7 and continued into Chenango County, then Otsego County, still traveling at a high rate of speed with no regard for public safety.

In the Town of Unadilla, the motorcycle began to sputter and slow down. After appearing to stop on Main Street, the operator jumped off the motorcycle and ran southbound into a trailer park. Deputies pursued on foot, giving multiple commands for the suspect to stop. The suspect ignored commands and until the pursuing deputy drew his Taser and pointed it at him, at which point the suspect complied and was taken into custody without further incident.

The operator of the motorcycle was identified as Ross T. Guglielmetti, age 22 of Deposit, NY. The motorcycle was found to have been reported stolen out of Endwell, NY by the New York State Police. The motorcycle was also found to have been spray painted and affixed with a unregistered license plate.

Following the investigation, Guglielmetti was charged with the following:

Ross T. Guglielmetti

- Criminal Possession of Stolen Property in the 3rd Degree, a Class D Felony
- Tampering with Physical Evidence, a Class E Felony
- Unlawful Fleeing a Police Officer in a Motor Vehicle in the 3rd Degree, a Class A Misdemeanor
- Obstruction of Governmental Administration in the 2nd Degree, a Class A Misdemeanor
- Reckless Endangerment in the 2nd Degree, a Class A Misdemeanor
- Resisting Arrest, a Class A Misdemeanor
- Multiple traffic violations

"Excellent work by our BCSO Road Patrol Deputies," said Sheriff Fred Akshar. "Let this be a simple lesson to those who think they can escape the consequences of endangering the safety of our Broome County residents: Think twice and don't run. We will find you and you will answer for your crimes."
