The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Veronica L. Arnold, age 44 of Whitney Point, NY, was charged with Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor, following an investigation into a narcotics complaint in the Town of Union.

Kenneth R. Degroat, Jr., age 34 of Windsor, NY, was charged with Obstruction of Governmental Administration in the 2nd Degree, a Class A Misdemeanor, and multiple traffic violations, following a traffic stop in the Town of Windsor.

Ethan B. Falciola, age 23 of Johnson City, NY, was charged with Driving While Intoxicated (1st Offense), a Misdemeanor, and multiple traffic violations following a traffic stop in the City of Binghamton.

James H. Gilkeson, age 68 of Kirkwood, NY, was charged with Obstruction of Governmental Administration in the 2nd Degree, a Class A Misdemeanor, following a warrant execution in the Town of Kirkwood.

Dominick S. Howe, age 32 of Johnson City, NY was charged with Criminal Impersonation in the 2nd Degree, a Class A Misdemeanor, following a warrant execution in the Town of Dickinson.

Landon M. Maynard, age 19 of Windsor, NY, was charged with two counts of Rape in the 2nd Degree, Class D Felonies, following multiple statutory rape investigations in the Town of Windsor.

Stepan I. Mykytyuk, age 72 of the Town of Dickinson, NY, was charged with Assault in the 3rd Degree, Criminal Obstruction of Breathing or Blood Circulation and Criminal Mischief in the 4th Degree, Class A Misdemenaors, following an investigation into a domestic incident in the Town of Dickinson.

Felisha M. Rodriguez, age 35 of Johnson City, NY, Operating a Motor Vehicle w/ a BAC >.08 (1st Offense) and Aggravated Driving While Intoxicated (BAC > .18), Misdemeanors, following a traffic stop in the Town of Maine.

John T. Short, age 56 of Lisle, NY, was charged with Criminal Contempt in the 2nd Degree, a Class A Misdemeanor, following an investigation into an order of protection violation in the Town of Barker.
