## BROOME COUNTY SHERIFF'S OFFICE PRESS RELEASE

### *Sheriff's Office Continues Search for Missing Endicott Man*

#### Nearby Residents Urged to Check Doorbell Cameras, Ancillary Buildings and Sheds

(TOWN OF UNION, NY) Based on numerous tips, video surveillance and witness reports, Broome County Sheriff's Investigators believe the missing Endicott man spent several hours in the area near the intersection of North McKinley Ave. and Woodrow Ave. in the Town of Union.

Joseph Maine, 48 yrs. old of Endicott, NY reportedly left his house on foot on the evening of Saturday, April 19, 2025 and never returned home. Witness reports and video surveillance spotted Maine multiple times on Saturday evening and the early morning hours of Sunday, April 20, 2025 traveling on foot through multiple locations within the nearby area.

Reportedly diabetic, Maine may not have taken his medication recently and may be exhibiting confused behavior.

Neighbors in the surrounding mile are urged to check their doorbell cameras and security cameras between the hours of 9:00 PM on Saturday, April 19, 2025 and today for any evidence of Maine walking through their property. Residents are also urged to check their property and backyard areas, including all sheds, garages or ancillary buildings for signs that Maine might have taken shelter or passed through.

Maine is described as a White Male, standing 6'0" and weighing approximately 167 lbs. He was last seen wearing a light grey sweatshirt, dark grey sweatpants, a black baseball cap with a fishhook hanging from it, and black sneakers with "FUBU" in red lettering.


# MISSING PERSON: Joseph Maine
