## BROOME COUNTY SHERIFF'S OFFICE PRESS RELEASE

### May 5, 2026 Weekly Arrests

The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Whitehead, age 46 of the Town of Dickinson, NY, was charged with Criminal Possession of a Controlled Substance in the 5<sup>th</sup> Degree, a Class D Felony, Criminal Use of Drug Paraphernalia in the 2<sup>nd</sup> Degree, a Class A Misdemeanor, and Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree, a Class A Misdemeanor, following a narcotics investigation in the Town of Dickinson.
