The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Nicholas G. Torres, age 58 of Binghamton, NY, was charged with Driving While Intoxicated (1<sup>st</sup> Offense) and Unlicensed Operation of a Motor Vehicle (BAC >.08), Misdemeanors, along with several traffic violation, following a traffic stop in the City of Binghamton.
