## **BROOME COUNTY SHERIFF'S OFFICE PRESS RELEASE**

Endicott Man Charged for Stabbing Individual
During Laundry Dispute in Town of Union

(TOWN OF UNION, NY) An Endicott man is facing a felony charge after a dispute in the laundry room of an apartment complex in the Town of Union escalated into a stabbing that left one man hospitalized.

On Monday, September 3, 2024 at approximately 6:00 PM, Broome County Sheriff's Office Road Patrol a responded to a 911 call reporting that a male had been stabbed in the chest at an apartment complex on 207 Bornt Hill Rd in the Town of Union.

Upon arrival, patrols located the victim lying on the ground of the parking lot of the complex, with two witnesses providing first aid. Responding deputies immediately provided life-saving measures, applying direct pressure and utilizing a chest seal until EMS arrived. The victim was then transported to UHS Wilson Hospital, where he remains in serious condition.

According multiple witnesses, Janzer J. Canelo, age 32 of Endicott, NY, and the victim were both residents of the apartment complex and had been in an ongoing dispute over laundry. At approximately 6:00 PM, the dispute escalated into a physical altercation in the laundry room of the apartment complex that ended when the victim was stabbed with a knife, according to witnesses.

Following an investigation conducted by BCSO detectives and deputies, Janzer J. Canelo was charged with Assault in the 1<sup>st</sup> Degree (With Intent to Cause Serious Injury with a Weapon), a Class B Felony.

Canelo was arrested and transported to Central Arraignment Part for arraignment remains in custody at the Broome County Sheriff's Correctional Facility.

"Excellent work by our responding deputies, who took immediate, lifesaving measures until EMS arrived and helped save the life of the victim of this senseless crime," said Sheriff Fred Akshar. "Thank you to our partners in law enforcement and our team of detectives and deputies for all their work to secure the area, collect evidence and ensure that this case was resolved quickly and efficiently."

The Broome County Sheriff's Office was assisted by the New York State Police, Endicott Police, Union Volunteer Emergency Squad and the Broome Volunteer Emergency Squad.
