Ricki R. Stanton, Jr., age 44 of Lisle, NY, was charged with Criminal Contempt in the 2nd Degree, a Class A Misdemeanor, following an investigation into an Order of Protection violation in the Town of Fenton.

Brittney N. Terrell, age 23 of Port Crane, NY, was charged with Criminal Possession of Stolen Property in the 4th Degree, a Class E Felony, following an investigation into a stolen vehicle in the Town of Fenton.
